Instructions:

Please complete and sign the following application to the best of your ability. The application includes tables to help you to determine your sign area capacity, permanent sign allowance, increases in permanent sign allowance and design enhancements. An appropriate application fee payable to the City of Cuyahoga Falls Planning Division.

In addition to the application, you must supply the following items:

- Site Plan showing all proposed and existing sign locations, buildings, drives, parking lots, property lines and right-of-ways.
- Building elevations, indicating locations of all surface signs. Sign height from top of grade and cross sections for non-surface signs.
- Specifications, materials, color, dimensions of all signs.
- ☐ For electronic signs, provide complete nits and other illumination specifications.
- Evidence of ownership or approval to install signs.

Chapter 1146 Sign Design should be reviewed in order to understand the City's sign regulations. The sign regulations are part of the Cuyahoga Falls General Development Cod which is available at www.cityofcf.com.

All new or modified signs must obtain this zoning certificate prior to applying for a building permit from the Summit County Building Department.

** Maximum Non-Surface Sign height is 20 feet. Any Non-Surface sign shall be reduced by 5 square feet for every 1- foot of sign height of such sign above 10-feet. (In Showcase areas, the maximum height is 10 feet)

*** 100 square feet is the maximum size for a Standard Non-Surface sign. and 50 square feet is the maximum size for a Showcase Non-Surface sign. Both sides of Non-Surface signs are counted in square footage calculations.

****PLEASE NOTE THAT WINDOW SIGNS MUST BE CALCULATED INTO TOTALS. YOU CANNOT COVER MORE THAN 40% OF ALL WINDOWS.

*****Also, a minimum of one sign on each lot or building site shall display the street number of the property in numerals of sufficient size to be clearly visible from vehicles in the abutting street.
