**Temp. Ord. B-108**

An ordinance authorizing the Mayor to enter into an amendment of Contract No. 6613 with the International Association of Firefighters, Local 494, and declaring an emergency.

Mr. Janis stated this ordinance authorizes the Mayor to sign an amendment to Contract No. 6613, and extends the contract to December 31, 2013. He asked for the Committee's approval to consider and pass this legislation pursuant to the presentation given in executive session.

Mrs. Hummel moved to bring out B-108 with a favor recommendation, second by Mr. Iula. Motion passed (2-0).

**Temp. Ord. B-109**

An ordinance authorizing the Mayor to enter into an amendment of Contract No. 6619 with the Ohio Patrolmen's Benevolent Association, and declaring an emergency.

Mr. Janis stated this ordinance authorizes the Mayor to sign an amendment to Contract No. 6619 representing patrol officers and community service officers, and asked for the Committee's approval to consider and pass this legislation pursuant to the presentation given in executive session.

Mrs. Hummel moved to bring out B-109 with a favor recommendation, second by Mr. Iula. Motion passed (2-0).

**Temp. Ord. B-110**

An ordinance authorizing the Mayor to enter into an amendment of Contract No. 6616 with the Ohio Patrolmen's Benevolent Association, and declaring an emergency.

Mr. Janis stated this ordinance authorizes the Mayor to sign an amendment to Contract No. 6616 representing police supervisors, and asked for the Committee's approval to consider and pass this legislation pursuant to the presentation given in executive session.

Mrs. Hummel moved to bring out B-110 with a favor recommendation, second by Mr. Iula. Motion passed (2-0).

**Temp. Ord. B-111**

An ordinance authorizing the Mayor to enter into an amendment of Contract No. 6640 with the Fraternal Order of Police, Ohio Labor Council, Inc., and declaring an emergency.

Mr. Janis stated this ordinance authorizes the Mayor to sign an amendment to Contract No. 6640 representing dispatchers, and extended the contract to December 31, 2013. He asked for the Committee's approval to consider and pass this legislation pursuant to the presentation given in executive session.

Mrs. Hummel moved to bring out B-111 with a favor recommendation, second by Mr. Iula. Motion passed (2-0).

**Temp. Ord. B-112**

An ordinance authorizing the Mayor to enter into an agreement with the American Federation of State, County and Municipal Employees (AFSCME), Local 2662, effective November 1, 2011, and declaring an emergency.

Mr. Janis stated this ordinance authorizes the Mayor to enter into a new agreement with AFSCME Local 2662 beginning November 1, 2011 through December 31, 2013 covering a variety of items. He asked for the Committee's approval to consider and pass this legislation pursuant to the presentation given in executive session.

Mrs. Hummel moved to bring out B-112 with a favor recommendation, second by Mr. Iula. Motion passed (2-0).

Mrs. Hummel stated she appreciated the cooperation of the bargaining units represented in these pieces of legislation, which covered everyone except electrical workers and nonbargaining employees.
