Miscellaneous Business

The President recognized the Mayor with respect to his nominations to the Planning Commission and the Board of Zoning Appeals. The Mayor stated that Jake Ricker resides at 2931 – 8th Street, and will be serving in

a new 5-year term expiring December 31, 2019. He is born and raised in Cuyahoga Falls and is the branch manager at PNC Bank. He has served on the Chamber of Commerce, including as its President. He has been nominated as the 2015 Citizen of the Year by the Chamber of Commerce. Deborah Monaco resides at 1340 Broad Blvd. She will fill Mary Nichols-Rhodes unexpired term ending December 31, 2018. She is a graduate of Kent State Univ. and Ohio State school of law. She has served as a magistrate in Domestic Relations Court. She is a business owner. Terry Gehring resides at 1550 – 20th Street. Mr. Gehring served for 15 years on the Board of Zoning Appeals.

The President thanked the nominees for their willingness to serve in these important roles.

Motion by Mr. Brillhart to approve the nominations to the Planning Commission and the Board of Zoning Appeals as requested in the Mayor's letters dated April 21, 2015. Seconded by Mr. James. Motion adopted by acclamation, 11-0.

The President recognized the Finance Director Bryan Hoffman with respect to Report 21 for the period ending March 31, 2015. Mr. Hoffman stated that an unexpected real estate tax revenue refund in the amount of \$61,000 will be received from the County Fiscal Officer. Income tax revenues are up 10% year-over-year from 2014. Unexpected revenue shortfalls in the Electric fund in the first months of this year, reported previously, have been attributed to a timing anomaly caused by unexpected warm weather in late 2014. The unexpected warm weather in November and December caused collections to fall in January and February, when bills for those months were paid. March and April revenues appear to be normal. The Finance Dept. is continuing to monitor this. Membership revenue in the Leisure Time Fund is up 4.8% year-overyear from 2014. Aggressive marketing has improved membership performance at the Natatorium. On the expense side, overtime in the Fire Dept. has been less than expected. Overtime in the Police Dept. has been higher than expected, due to shift-covering necessary due to short staffing. New recruits hired to fill open positions are still being trained. In Building & Grounds, natural gas usage in City Hall and Natatorium has been higher than expected due to the cold winter. However, fuel usage has been down \$115,000 year-over-year from 2014 due to lower fuel costs. Parts and repair service costs are up, due to the cold winter. There are two timing issues to be explained. In the Sewer Fund, treatment charges from City of Akron were not paid until April 3. In 2014 this bill was In the state highway improvement fund and income paid on March 24. tax funds, expenditures for salt will be reimbursed from later in the year.

The President recognized Mr. Colavecchio, who asked about specific dollar amounts for natural gas usage. Mr. Hoffman stated the dollar amount difference is only \$2,000 to \$3,000.

The President recognized Mr. Weinhardt, who asked if the increase in natural gas expenditures at the Natatorium exceeded the new income from memberships. Mr. Hoffman stated that the natural gas expenditures were less than the new income. Membership revenue was up about \$46,000 while natural gas expenditures were up only a few thousand dollars as previously stated.

Motion by Mr. James to adjourn. Seconded by Mr. Iula. Motion adopted by acclamation. The meeting was adjourned at 6:52 p.m.
