A-13: An ordinance approving regulatory text amendments to Section 1112.04, Title 1, Part 11, titled "Design and Historic Review Board" and Section 1132.21 of Chapter 1132, Title 3, Part 11, title "H, Historic Overlay" of the Codified Ordinances of the City of Cuyahoga Falls (General Development Code), and declaring an emergency.

Remarks by the Committee Chair: Although the substitute contains substantial changes, Mr. Guerra has stated this is a clean-up of existing zoning which already existed concerning this subject matter, which must be sent to Columbus to authorize the creation of this committee.

The Chair stated that the Design & Historic Review Board shall consist of seven members, including two *ex officio* members, one of whom shall be the President of City Council and the other the Chair of the Planning & Zoning Committee.
