

**Cuyahoga Falls City Council**  
**Minutes of the Finance Committee Meeting**  
**March 6, 2006**

Mr. Gorbach called the meeting to order at 6:20 p.m.

The minutes of February 21, 2006 were approved as submitted.

Mr. Gorbach said that A-10 and A-32 will be held until further notice.

**Discussion:**

***Temp. Ord. A-8***

An ordinance levying special assessments for the repair or replacement of sidewalks in the district known and designated by this Council as a Sidewalk Repair District for the year 2005 containing all necessary streets, alleys or public roadways within the corporate limits of the City of Cuyahoga Falls, and declaring an emergency.

Mr. Gorbach read A-8 (second reading). He referred to several changes to wording in the ordinance. Line 18 the words "January 26, 2004" should read "January 28, 2005". End of Line 18 "2004" should read "2005".

Mr. Brodzinski said this ordinance gives the City authority to levy assessments for sidewalk repair or replacement for 2005.

Mrs. Pyke asked when the assessments must be paid. Mr. Brodzinski said one year.

***The committee recommended bringing out Temp. Ord. A-8 for approval.***

**Sub. Temp. Ord. A-12**

An ordinance authorizing the Mayor, as Director of Public Safety to enter into a contract or contracts according to law for the maintenance of the Rolm/Advantage telephone system, and declaring an emergency.

Mr. Gorbach read Sub.A-12 (second reading). Mr. Sabino said this ordinance allows for a 3-year contract at an annual cost of \$17,206.

*The committee recommended bringing out Sub. Temp. Ord. A-12 for approval.*

**Temp. Ord. A-31**

An ordinance authorizing the Mayor to enter into a contract or contracts with a firm or firms for community correctional services, and declaring an emergency.

Mr. Gorbach read A-31 (second reading). Mr. Arrington said this is a 1-year contract with Oriana House.

Mrs. Klinger asked if the contract with Oriana House is exclusive. Mr. Arrington said no, but we only pay if the court sentences someone to Oriana which has an indigent program. The City will pay if the indigent defendant cannot.

*The committee recommended bringing out Temp. Ord. A-31 for approval.*

**Temp. Ord. A-34**

An ordinance authorizing the Mayor to enter into a contract and/or contracts, according to law, for the purchase of nine self-contained breathing apparatus units for use by the Fire Department, and declaring an emergency.

Mr. Gorbach read A-34 (second reading). Chief Snyder said this ordinance is to replace out-of-date breathing apparatus units with state-of-the-art units that are lighter, safer and more effective.

*The committee recommended bringing out Temp. Ord. A-34 for approval.*
