Substitute Temp. Ord. B-27 (dated June 15, 2007)

An ordinance amending Sections 921.01, 921.02, 921.03, 921.04, 921.05, 921.08, 921.09, and 921.10, and repealing Sections 923.02, 933.09, 933.13 and 933.14 of the Codified Ordinances of the City of Cuyahoga Falls and declaring an emergency.

Mr. Gorbach moved to amend Substitute Temp. Ord. B-27 (dated 6-15-07) by amending line 121 by inserting the words "water and sewer" before the word "utilities" at the end of that line; second by Mr. James. Motion passed, voice vote (11-0).

Mr. Flinn moved to amend Substitute Temp. Ord. B-27 (dated 6-15-07) by eliminating all language in lines 117 through 133, with the exception of the sentence beginning with the words "Upon application" in line 128 and ending with the word "deposit" in line 129; second by Mr. Barnhart. Roll call: Mr. Mader, yes; Mrs. Klinger, yes; Mrs. Pyke, yes; Mrs. Colavecchio, no; Mrs. Hummel, no; Mr. Gorbach, no; Mrs. Ritzinger, no; Mr. James, no; Mr. Flinn, yes; Mr. Barnhart, yes; Mr. Walters, no. Motion failed (5-6).

Mr. Flinn moved to amend Substitute Temp. Ord. B-27 (dated 6-15-07) in line 112 by replacing the amount of "\$10.00" with "\$30.00"; second by Mr. Barnhart. Motion passed, voice vote (11-0).

Mr. Gorbach moved to adopt amended Substitute Temp. Ord. B-27 (dated 6-15-07), second by Mr. James. Motion passed, voice vote (10-1)
