## Minutes of the PUBLIC AFFAIRS COMMITTEE Meeting

Mary Ellen Pyke brought the Public Affairs Committee to order at 7:23 p.m. All members of the Committee were present. The minutes of 6-6-05 were approved as submitted.

#### **Scheduled legislation (second reading):**

B-89	An Ordinance amending Chapter 141 of the Codified Ordinance by the addition of section 141.04, and declaring an emergency.

Vigil indicates the policy of sexual predators at the Natatorium and other parks are being strengthened. This precludes the entrance of a registered sex offenders to our park facilities. This takes our policy to another level. It is a criminal trespassing charge. Mr. Conley indicates we will arrest offenders. There will be signs posted. This only controls property owned by the city not schools or their playgrounds. Mr. Gorbach asks if there is a standard operating procedure for confronting a person of this nature. The manager would handle the situation.

B-90	An Ordinance amending the traffic control file by providing for installation of the traffic control devices, and declaring an emergency.

Chief Conley indicates the first is for 21st St. near Broad Blvd. There is a "no Parking this side of street". We are looking for good vision around that area. The second is on North Haven Blvd. Near Bolich school. With the changes entering the school now, the straight/left from the North Haven Blvd needs adopted.

B-91	An Ordinance authorizing the Mayor to grant a license to Riverside Realty Company, owner of property located at 2235 Front Street to use a portion of the City's property for outdoor dining, and declaring an emergency.

Jennifer Syx indicates this a similar agreement for outdoor dining for the Riverfront Coffee Mall. This allows Kelly Steele to place plantars, tables and chairs for customers.

Mary Ellen indicates this is a good opportunity for outdoor eating. Mr. Flinn would like to actively pursue this type of agreements with other eating facilities. People enjoy eating outdoors.

B-92	A Resolution authorizing the filing of a grant application with the State of Ohio to participate in the Clean Ohio Revitalization Fund and, declaring an emergency.
