## MINUTES OF PUBLIC HEARING

### May 17, 2021

### Temp. Ord. B-15

An ordinance approving a regulatory text amendment to Table 1131-1 Zoning Districts and Uses to allow Vehicle Wash/Detailing as a conditional use in MU-3 Sub-Urban Center and MU-5 Urban Center Districts, and declaring an emergency.

On the 17<sup>th</sup> of May, via Zoom, at 6:30 p.m. EST, public hearings were called to order and conducted regarding Temp. Ord. B-15 dealing with amending specific sections of the Codified Ordinances of the City of Cuyahoga Falls, Ohio. Notice of the hearings were published twice in the Falls News Press, a newspaper of general circulation in the City of Cuyahoga Falls, at least fourteen days prior to the date of these hearings, to-wit: April 18, 2021. A true and accurate copy of the published Notices are attached to these Minutes.

Mr. Adam Paul, Senior Planner, presented Temporary Ordinance B-15 to Council. Mr. Brian Krusz, Director of Growth & Development, Managing Partner at Sgt. Clean's Car Wash, stated that he had reached out to several Council members about putting a car wash on the corner of Front Street and Hudson Drive. They have done research and market studies, as well as an analysis of being over 400 or 500 feet away from any residents from their location at the corner of Front Street and Hudson Drive. They will also enter traffic studies as they continue the planning process. At this particular point, they would appreciate an opportunity to be a part of Cuyahoga Falls. Passage of this legislation does not short circuit the regular process that needs to be done by the Planning Commission and Planning Department. They would still need to go through site plan approval, including the conditional use process and meeting all the requirements therein. All this does is allow this process to work its way through an approval process and set the use at the specific location we are looking at.

Mr. Thomas Sullivan, 447 Tallmadge Road, Cuyahoga Falls, submitted an e-mail in opposition of Temporary Ordinance B-15 that was read into the record and attached to these minutes.

Mr. Greg Seifert, 3390 Verner Road, Stow, spoke in support of Temporary Ordinance B-15.

No further comments, either for or against the legislation, were offered by anyone in attendance.
