AN ORDINANCE AUTHORIZING THE MAYOR AND DIRECTOR OF PUBLIC SERVICE TO ENTER INTO CONTRACTS FOR THE PURCHASE AND/OR LEASE OF VARIOUS VEHICLES FOR USE BY THE CITY, AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit, and State of Ohio, that:

<u>Section 1.</u> The Directors of Safety and/or Public Service as appropriate are hereby authorized to enter into various contracts for the purchase and/or lease of the vehicles listed on Exhibit A attached hereto.

Section 2. It is hereby found and determined that the used automated packer truck identified on Exhibit A and further identified here by its VIN#5SXHANCY38RZ61836261836 is a unique, non-fungible item due to its characteristics, and purchase of said item is therefore not susceptible to conventional competitive bidding. The Director of Public Service is authorized to purchase said item by direct purchase for the price identified in Exhibit A, which this Council determines to be fair market value.

Section 3. Said contracts shall be entered into under the authority of properly approved purchasing cooperatives or any other procedure authorized by law.

Section 4. The Director of Finance is hereby directed to make payment for same out of funds lawfully appropriated therefore.

<u>Section 5.</u> Any ordinances or resolutions or portions of ordinances and resolutions inconsistent herewith be and the same are hereby repealed, but any ordinances and resolutions not inconsistent herewith and which have not previously been repealed are hereby ratified and confirmed.

Section 6. It is found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements including Chapter 107 of the Codified Ordinances.

Section 7. This ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga Falls and the inhabitants thereof, and provided it receives the affirmative vote of two-thirds of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force at the earliest period allowed by law.
