6 ORDINANCE NO. 27 - 2011

8 AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A  
9 COLLECTIVE BARGAINING AGREEMENT WITH LOCAL 399 OF  
10 THE UTILITY WORKERS' UNION OF AMERICA, AFL-CIO,  
11 EFFECTIVE JANUARY 1, 2011, AND DECLARING AN  
12 EMERGENCY.

14 WHEREAS, Ohio Revised Code Chapter 4117 authorizes public employees to bargain  
15 collectively with public employers regarding wages, hours, terms and other conditions of  
16 employment and to enter into collective bargaining agreements; and

17  
18 WHEREAS, the Mayor and his representatives and Local 399 of the Utility Workers' Union of  
19 America, AFL-CIO, have bargained collectively and in good faith and said bargaining has resulted  
20 in a tentative agreement on a collective bargaining agreement effective January 1, 2011; and

22 WHEREAS, on or about March 12, 2011 the membership of the Union ratified said collective  
23 bargaining agreement; and

25 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County  
26 of Summit and State of Ohio, that:



28 Section 1. The Mayor is hereby authorized to enter into a collective bargaining agreement on  
29 the basis of the tentative contract negotiated with and ratified by Local 399 of the Utility Workers'  
30 Union of America, AFL-CIO, effective January 1, 2011.



32 Section 2. Any other ordinances and resolutions or portions of ordinances and resolutions  
33 inconsistent herewith are hereby repealed but any ordinances and resolutions or portions of  
34 ordinances and resolutions not inconsistent herewith and which have not previously been  
35 repealed are hereby ratified and confirmed.

37 Section 3. It is found and determined that all formal actions of this Council concerning and  
38 relating to the adoption of this ordinance were adopted in an open meeting of this Council and  
39 that all deliberations of this Council and of any of its committees that resulted in such formal  
40 action were in meetings open to the public, in compliance with all legal requirements including  
41 Chapter 107 of the Codified Ordinances.

43 Section 4. This ordinance is hereby declared to be an emergency measure necessary for the  
44 preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga  
45 Falls and the inhabitants thereof and provided it receives the affirmative vote of two-thirds of the  
46 members elected or appointed to Council, it shall take effect and be in force immediately upon its  
47 passage and approval by the Mayor; otherwise it shall take effect and be in force at the earliest  
48 period allowed by law.
