ORDINANCE NO. 54 - 2012

AN ORDINANCE AUTHORIZING AND DIRECTING THE APPROPRIATION OF CERTAIN INTERESTS IN REAL PROPERTY NECESSARY FOR THE IMPROVEMENT OF STATE ROAD BETWEEN GRAHAM ROAD AND STEELS CORNERS ROAD, AND DECLARING AN EMERGENCY.

WHEREAS, on April 9, 2012, this Council adopted Resolution No. 11-2012, declaring the intention of the City to appropriate certain interests in real property necessary for the improvement of State Road between Graham Road and Steels Corners Road, and caused notice thereof to be served on the owners thereof as required by law, and

WHEREAS, despite diligent efforts, the City and property owners have been unable to agree to the terms by which the necessary land will be transferred to the City, and

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Cuyahoga Falls, County of Summit and State of Ohio, that:

Section 1. This Council authorizes and directs the appropriation of certain interests in real property necessary for the improvement of State Road between Graham Road and Steels Corners Road as more fully described in the exhibits numbered A(004 WD&T), A(007 T), A(015 WD, T1 & T2), A(25 SH, T1, T2, & U), A(045 S), A(054 S, T1 & T2), A(058 WD & T), A(073 WD & T), A(073 BS), A(075 WD, T1 & T2), and A(081 WD & T), which are on file with the Clerk of Council in Council File No. \_\_\_\_\_ and incorporated as if fully rewritten herein.

<u>Section 2.</u> The Director of Law is hereby authorized to file any necessary civil actions in the Summit County Probate Court, or any other court of competent jurisdiction, to provide for the appropriation of the real property interests mentioned in Section 1 hereof by eminent domain and the assessment of the compensation to be paid for the interests hereby appropriated.

Section 3. The Director of Finance is hereby authorized to deposit with the Court the amount of the appraised value of each of the real property interests mentioned in Section 1 hereof, which is on file with the Clerk of Council in Council File No. \_\_\_\_\_ and incorporated as if fully rewritten herein, to permit the immediate appropriation of the property. The Director of Finance is hereby authorized to make payment for the same out of the Capital Projects Fund, line item Capital Outlay.

<u>Section 4.</u> Any other ordinances and resolutions or portions of ordinances and resolutions inconsistent herewith are hereby repealed, but any ordinances and resolutions or portions of ordinances and resolutions not inconsistent herewith and which have not previously been repealed are hereby ratified and confirmed.

Section 5. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, to the extent applicable, including Chapter 107 of the Codified Ordinances.
