6 ORDINANCE NO. 604 - 2012

8 AN ORDINANCE APPROVING AN AMENDMENT TO THE  
9 COMMUNITY DEVELOPMENT BLOCK GRANT ANNUAL ACTION  
10 PLAN FOR FISCAL YEAR 2011, AND DECLARING AN EMERGENCY.

12 WHEREAS, in Ord. No. 46-2011, passed April 25, 2011, this Council approved the 2011  
13 Community Development Block Grant (CDBG) Annual Action Plan for HUD Fiscal Year 2011, and  
14

15 WHEREAS, the CDBG Consolidated Plan, adopted for the years 2009-2013, requires that any  
16 substantial amendment to an Annual Action Plan which increases the funding level reported therein be  
17 first approved by this Council, after a 30-day notice and comment period and a public hearing,  
18

19 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of  
20 Summit, and State of Ohio, that:

22 Section 1. The 2011 Community Development Block Grant Annual Action Plan, as amended  
23 pursuant to the proposed amendment currently on file with the Clerk of Council in Council File No.  
24 604-2012, is hereby approved, and the Community Development Department is authorized to carry out the  
25 programs contained in these documents.

26  
27 Section 2. Any other ordinances or resolutions or portions of ordinances and resolutions  
28 inconsistent herewith are hereby repealed, but any ordinances and resolutions not inconsistent  
29 herewith and which have not previously been repealed are hereby ratified and confirmed.


31 Section 3. It is found and determined that all formal actions of this Council concerning and  
32 relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all  
33 deliberations of this Council and of any of its committees that resulted in such formal action, were in  
34 meetings open to the public, in compliance with all legal requirements, to the extent applicable,  
35 including Chapter 107 of the Codified Ordinances.


37 Section 4. This ordinance is hereby declared to be an emergency measure necessary for the  
38 preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga Falls  
39 and the inhabitants thereof, for the reason that it is immediately necessary to permit timely and  
40 appropriate development of this property, and provided it receives the affirmative vote of two thirds of  
41 the members elected or appointed to Council, it shall take effect and be in force immediately upon its  
42 passage and approval by the Mayor; otherwise it shall take effect and be in force at the earliest period  
43 allowed by law.
