9 AN ORDINANCE AUTHORIZING THE DIRECTOR OF
10 PUBLIC SERVICE TO ENTER INTO A CONTRACT OR
11 CONTRACTS, ACCORDING TO LAW, FOR CONCRETE
12 AND MASONRY REPAIRS TO THE CITY-OWNED
13 PARKING GARAGES LOCATED AT 2035 OLD TOWN
14 LOOP (THE "BLUE" PARKING DECK), 2052 FRONT
15 STREET (THE "RED" PARKING DECK), AND 2318
16 SECOND STREET (THE "GREEN" PARKING DECK)
17 AND DECLARING AN EMERGENCY.
18

19 BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of
20 Summit and State of Ohio, that:

22 Section 1. The Director of Public Service is hereby authorized to enter into a
23 contract or contracts, according to law, for concrete and masonry repairs to the
24 City-owned parking garages located at 2035 Old Town Loop(the "Blue" Parking
25 Deck), 2052 Front Street (the "Red" Parking Deck), and 2318 Second Street (the
26 "Green" Parking Deck).

28 Section 2. The Director of Finance is hereby authorized and directed to make
29 payment for same from the Capital Projects Fund, line item Capital Outlay.
30

31 Section 3. Any other ordinances or resolutions or portions of ordinances and
32 resolutions inconsistent herewith are hereby repealed, but any ordinances and
33 resolutions not inconsistent herewith and which have not previously been repealed
34 are hereby ratified and confirmed.


36 Section 4. It is found and determined that all formal actions of this Council
37 concerning and relating to the adoption of this ordinance were adopted in an open
38 meeting of this Council, and that all deliberations of this Council and of any of its
39 committees that resulted in such formal action, were in meetings open to the
40 public, in compliance with all legal requirements, to the extent applicable,
41 including Chapter 107 of the Codified Ordinances.
42

43 Section 5. This ordinance is hereby declared to be an emergency measure
44 necessary for the preservation of the public peace, health, safety, convenience and
45 welfare of the City of Cuyahoga Falls and the inhabitants thereof, for the reason
46 that it is immediately necessary to permit timely and appropriate development of
47 this property, and provided it receives the affirmative vote of two thirds of the
48 members elected or appointed to Council, it shall take effect and be in force


49 immediately upon its passage and approval by the Mayor; otherwise it shall take
50 effect and be in force at the earliest period allowed by law.


