ORDINANCE NO. 22 - 2014

AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO APPLY FOR AND ACCEPT A GRANT FROM THE OHIO BUREAU OF WORKERS' COMPENSATION, MAKING AN APPROPRIATION THEREFOR, AND DECLARING AN EMERGENCY.

WHEREAS the State of Ohio through the Bureau of Workers' Compensation Safety Intervention SafetyGRANTS Program administers financial assistance to employers for the purchase of safety and/or industrial equipment, and

WHEREAS the City of Cuyahoga Falls desires financial reimbursement under the SafetyGRANTS Program,

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit and State of Ohio, that:

<u>Section 1.</u> The Director of Public Service is hereby authorized to apply for and accept the SafetyGRANTS Program financial assistance from the Ohio Bureau of Workers' Compensation Safety Intervention SafetyGRANTS Program, on behalf of the City of Cuyahoga Falls, for the purposes set forth in the grant application and grant agreement.

<u>Section 2.</u> The Director of Public Service is hereby authorized and directed to enter into agreements that may be necessary to apply for and accept the financial assistance mentioned herein.

<u>Section 3.</u> The Director of Finance agrees that it has and will obligate the funds required to satisfactorily complete the project under the terms and conditions of the agreement if the project is accepted for financial assistance.

<u>Section 4.</u> The Director of Finance is hereby authorized and directed to increase appropriations in the Capital Projects Fund, Line Item Capital Outlay, in the amount of \$17,393.

<u>Section 5</u>. Any other ordinances and resolutions or portions of ordinances and resolutions inconsistent herewith are hereby repealed, but any ordinances and resolutions or portions of ordinances and resolutions not inconsistent herewith and which have not previously been repealed are hereby ratified and confirmed.

<u>Section 6</u>. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open

to the public, in compliance with all legal requirements including Chapter 107 of the Codified Ordinances. Section 7. This ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga Falls and the inhabitants thereof and provided, it receives the affirmative vote of two-thirds of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force at the earliest period allowed by law.
