AN ORDINANCE AUTHORIZING THE DIRECTOR OF
PUBLIC SERVICE TO ENTER INTO A CONTRACT OR
CONTRACTS, ACCORDING TO LAW, FOR THE
PURCHASE OF ANNUAL REQUIREMENTS OF
CERTAIN MATERIALS, SUPPLIES AND SERVICES
FOR USE BY THE GARAGE DIVISION DURING 2015.

AND DECLARING AN EMERGENCY.

BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit and State of Ohio, that:

<u>Section 1</u>. The Director of Public Service is hereby authorized to enter into a contract or contracts, according to law, for the purchase of certain materials, supplies and services for use by the Garage Division during 2015:

Fuel	\$968,500.00
Tires	\$70,00.00
Repairs	\$175,000.00
Parts	\$255,000.00

Notwithstanding and as an exception to Section 181.06 of the Codified Ordinances, expenditures made under the contracts authorized by this ordinance shall not exceed any of the estimates identified above, unless the Director first notifies City Council, in writing, that one or more of the expenditure estimates identified above will be exceeded.

<u>Section 2</u>. The Director of Finance is hereby authorized and directed to make payment for same from the Garage Fund, line item Other Operations.

<u>Section 3</u>. Any other ordinances and resolutions or portions of ordinances and resolutions inconsistent herewith are hereby repealed, but any ordinances and resolutions or portions of ordinances and resolutions not inconsistent herewith and which have not previously been repealed are hereby ratified and confirmed.

Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Chapter 107 of the Codified Ordinances.

Section 5. This ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga Falls and the inhabitants thereof for the reason that the supplies are necessary for the daily functioning of the Municipal
