AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SAFETY TO ENTER INTO A CONTRACT WITHOUT COMPETITIVE BIDDING WITH STRYKER CORPORATION FOR THE PURCHASE OF MODEL 6506 POWER PRO **AMBULANCE** COTS AND APPURTENANCES FOR USE IN THE FIRE DEPARTMENT, AND DECLARING AN EMERGENCY.

WHEREAS, Article I, Section 2 of the City Charter, adopted pursuant to Art. XVIII, Sections 3 and 7 of the Ohio Constitution, authorizes this Council to make exception to the competitive bidding procedures set forth in the Revised Code,

WHEREAS, Stryker Corporation is the sole source purveyor of the Model 6506 Power Pro Ambulance Cots.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit, and State of Ohio, that:

<u>Section 1</u>. The Director of Public Safety is hereby authorized to enter into a contract or contracts, without competitive bidding, with Stryker Corporation based upon the proposal dated August 20, 2015, for the purchase of Model 6506 Power Pro Ambulance Cots and appurtenances.

Section 2. The Director of Finance is hereby authorized and directed to make payment for same from the Capital Projects Fund, line item, Capital Outlay.

Section 3. Any ordinances or resolutions or portions of ordinances and resolutions inconsistent herewith are hereby repealed, but any ordinances and resolutions not inconsistent herewith and which have not previously been repealed are hereby ratified and confirmed.

Section 4. It is found and determined that all formal actions of this Council concerning and relating to the passage of this ordinance were taken in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public, in compliance with all legal requirements including Chapter 107 of the Codified Ordinances.

Section 5. That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga Falls and the inhabitants thereof,
