## ordinance no. 30 - 2017

AN ORDINANCE AUTHORIZING THE PARKS AND RECREATION BOARD TO APPLY FOR AND ACCEPT A GRANT FROM THE DEPARTMENT OF NATURAL RESOURCES, AND DECLARING AN EMERGENCY.

WHEREAS, the State of Ohio, through the Ohio Department of Natural Resources, administers financial assistance for public recreation purposes through the State of Ohio NatureWorks Program, and

WHEREAS, the City of Cuyahoga Falls desires financial assistance under the NatureWorks Program.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit and State of Ohio, that:

<u>Section 1</u>. The Parks and Recreation Board is hereby authorized to apply for and enter into agreements for grant funding from the NatureWorks Grant Program administered through the Ohio Department of Natural Resources for the construction of the Kennedy Park Tennis Court.

Section 2. The Parks and Recreation Board is hereby authorized to execute, certify and/or furnish other such documents and do all other actions as are necessary to further the grant application and grant agreements referred to in Section 1 of this ordinance, and which are incidental to carrying out the purposes of this ordinance.

Section 3. The City does agree to obligate the funds required to satisfactorily complete the project and become eligible for reimbursement under the terms of the NatureWorks Program.
