5 ORDINANCE NO. 32 - 2007

7 AN ORDINANCE AUTHORIZING THE DIRECTOR OF  
8 PUBLIC SERVICE TO ENTER INTO A CONTRACT OR  
9 CONTRACTS, ACCORDING TO LAW, FOR PROFESSIONAL  
10 SERVICES TO PLAN FOR, DESIGN AND CONSTRUCT A  
11 NEW PUBLIC ROADWAY, AND DECLARING AN  
12 EMERGENCY.

13  
14 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls,  
15 County of Summit and State of Ohio:

16  
17 Section 1. That the Director of Public Service is hereby authorized to enter into a  
18 contract or contracts, according to law, for planning, design and construction services  
19 to develop a new public roadway from Steels Corners Road to the Wyoga Lake Preserve.



21 Section 2. That the Director of Finance is hereby authorized and directed to make  
22 payment for same from the Community Development Block Grant Fund.

24 Section 3. That any other ordinances and resolutions or portions of ordinances and  
25 resolutions inconsistent herewith be and the same are hereby repealed, but any  
26 ordinances and resolutions or portions of ordinances and resolutions not inconsistent  
27 herewith and which have not previously been repealed are hereby ratified and  
28 confirmed.

29  
30 Section 4. That it is found and determined that all formal actions of this Council  
31 concerning and relating to the adoption of this ordinance were adopted in an open  
32 meeting of this Council and that all deliberations of this Council and of any of its  
33 committees that resulted in such formal action were in meetings open to the public, in  
34 compliance with all legal requirements including Chapter 107 of the Codified  
35 Ordinances.

36  
37 Section 5. That this ordinance is hereby declared to be an emergency measure  
38 necessary for the preservation of the public peace, health, safety, convenience and  
39 welfare of the City of Cuyahoga Falls and the inhabitants thereof and provided, it  
40 receives the affirmative vote of two-thirds of the members elected or appointed to  
41 Council, it shall take effect and be in force immediately upon its passage and approval  
42 by the Mayor; otherwise it shall take effect and be in force at the earliest period allowed  
43 by law.
