7 AN ORDINANCE AMENDING EXHIBIT A OF ORDINANCE 12-  
8 2007 ESTABLISHING PAY RANGES FOR PART-TIME, PER DIEM,  
9 AND SPECIAL CLASSIFICATION WORKERS, AND DECLARING  
10 AN EMERGENCY

12 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County  
13 of Summit and State of Ohio:

15 Section 1. That Exhibit A of Ordinance 12-2007 is hereby amended and replaced with the  
16 attached Exhibit A.



18 Section 2. That any other ordinances or resolutions or portions of ordinances and  
19 resolutions inconsistent herewith are hereby repealed, but any ordinances and resolutions not  
20 inconsistent herewith and which have not previously been repealed are hereby ratified and  
21 confirmed.

23 Section 3. That it is found and determined that all formal actions of this Council concerning  
24 and relating to the adoption of this ordinance were adopted in an open meeting of this Council  
25 and that all deliberations of this Council and of any of its committees that resulted in such formal  
26 action were in meetings open to the public, in compliance with all legal requirements including  
27 Chapter 107 of the Codified Ordinances.



29 Section 4. That this ordinance is hereby declared to be an emergency measure necessary for  
30 the preservation of the public peace, health, safety, convenience and welfare of the City of  
31 Cuyahoga Falls and the inhabitants thereof, and provided it receives the affirmative vote of  
32 two-thirds of the members elected or appointed to Council, it shall take effect and be in force  
33 immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in  
34 force at the earliest period allowed by law.
