ORDINANCE NO. 39 - 2013

AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO ISSUE AN ENCROACHMENT PERMIT TO THE WOODRIDGE LOCAL SCHOOL DISTRICT FOR THE PURPOSE OF INSTALLING AND OPERATING A PRIVATE SANITARY FORCE MAIN SEWER IN NORTHAMPTON AND WEST BATH ROADS, AND DECLARING AN EMERGENCY.

BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit and State of Ohio, that:


Section 1. The Director of Public Service is hereby authorized to issue an encroachment permit, revocable at the will of Council, to Woodridge Local School District, for the purpose of installing and operating a 2.5-inch diameter private sanitary force main sewer within the public rights-of-way of Northampton and West Bath Roads, from Woodridge Primary School, 3313 Northampton Road, to an existing sanitary sewer manhole at the intersection of West Bath Road and Woodhaven Drive. The permit shall be substantially in the form now on file with the Clerk in Council File No. \_\_\_\_\_ and shall contain such terms and conditions as are necessary in the opinion of the Director of Law to protect the public interest.


Section 2. Any other ordinances and resolutions or portions of ordinances and resolutions inconsistent herewith are hereby repealed, but any ordinances and resolutions or portions of ordinances and resolutions not inconsistent herewith and which have not previously been repealed are hereby ratified and confirmed.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Chapter 107 of the Codified Ordinances.

Section 4. This ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga Falls, and provided it receives the affirmative vote of two-thirds of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force at the earliest period allowed by law.
