5 ORDINANCE NO. 47 - 2007  
6

7 AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE  
8 TO EXECUTE A MODIFICATION OF THE CONTRACT FOR  
9 PROFESSIONAL ENGINEERING SERVICES FOR IMPROVEMENTS TO  
10 THE HOWE AVENUE AND MAIN STREET INTERSECTION, AND  
11 DECLARING AN EMERGENCY.  
12

13 WHEREAS, the City entered into an agreement with the Department of Transportation to cooperate in  
14 the improvement of the intersection of Howe Avenue and Main Street.  
15

16 WHEREAS, Ordinance 51-2005 authorized a contract for professional engineering services for  
17 improvements to the Howe Avenue and Main Street intersection.  
18

19 WHEREAS, additional engineering services are necessary.  
20

21 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit  
22 and State of Ohio:  
23

24 Section 1. That the Director of Public Service is hereby authorized to execute a modification of the  
25 contract with GPD Associates, in an amount not to exceed \$80,000.00, with the City's share not to exceed  
26 \$8,000.00.  
27

28 Section 2. That the Director of Finance is hereby authorized and directed to make payment for same  
29 in an amount not to exceed \$80,000.00 from the Capital Projects Fund, line item Capital, and increase  
30 appropriations within the Capital Projects Fund, line item Capital, by ~~\$53,000.00.~~  
31 <sup>272,000.00.</sup>

32 Section 3. That any other ordinances or resolutions or portions of ordinances and resolutions  
33 inconsistent herewith be and the same are hereby repealed, but any ordinances and resolutions not  
34 inconsistent herewith and which have not previously been repealed are hereby ratified and confirmed.  
35

36 Section 4. That it is found and determined that all formal actions of this Council concerning and  
37 relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all  
38 deliberations of this Council and of any of its committees that resulted in such formal action, were in  
39 meetings open to the public, in compliance with all legal requirements, to the extent applicable, including  
40 Chapter 107 of the Codified Ordinances.  
41

42 Section 5. That this ordinance is hereby declared to be an emergency measure necessary for the  
43 preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga Falls and  
44 the inhabitants thereof, for the reason that it is immediately necessary to permit timely and appropriate  
45 development of this property, and provided it receives the affirmative vote of two thirds of the members  
46 elected or appointed to Council, it shall take effect and be in force immediately upon its passage and  
47 approval by the Mayor; otherwise it shall take effect and be in force at the earliest period allowed by law.
