9 AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC  
10 SERVICE TO ENTER INTO A CONTRACT OR CONTRACTS,  
11 ACCORDING TO LAW, FOR THE REPAIR AND  
12 RESURFACING OF STEELS CORNERS ROAD FROM STATE  
13 ROAD TO WYNDHAM RIDGE DRIVE, IN THE CITY OF  
14 CUYAHOGA FALLS, AND DECLARING AN EMERGENCY.

17 BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit and  
18 State of Ohio, that:

19  
20 Section 1. The Director of Public Service is hereby authorized to enter into a contract or  
21 contracts, according to law, for the repair and resurfacing of Steels Corners Road from State  
22 Road to Wyndham Ridge Drive, in the City of Cuyahoga Falls.

24 Section 2. The Director of Finance is hereby authorized and directed to make payment  
25 for same from the Capital Projects Fund, line item Capital Outlay.

27 Section 3. Any other ordinances or resolutions or portions of ordinances and resolutions  
28 inconsistent herewith are hereby repealed, but any ordinances and resolutions not  
29 inconsistent herewith and which have not previously been repealed are hereby ratified and  
30 confirmed.

32 Section 4. It is found and determined that all formal actions of this Council concerning  
33 and relating to the adoption of this ordinance were adopted in an open meeting of this  
34 Council, and that all deliberations of this Council and of any of its committees that resulted  
35 in such formal action, were in meetings open to the public, in compliance with all legal  
36 requirements, to the extent applicable, including Chapter 107 of the Codified Ordinances.

38 Section 5. This ordinance is hereby declared to be an emergency measure necessary for  
39 the preservation of the public peace, health, safety, convenience and welfare of the City of  
40 Cuyahoga Falls and the inhabitants thereof, and provided it receives the affirmative vote of  
41 two thirds of the members elected or appointed to Council, it shall take effect and be in force  
42 immediately upon its passage and approval by the Mayor; otherwise it shall take effect and  
43 be in force at the earliest period allowed by law.
