ORDINANCE NO. 100 - 2017

AN ORDINANCE AMENDING THE COMPANY NAME OF THE SGS TOOL COMPANY & CROOKED RIVER REALTY, LLC/HAAG INVESTMENTS TO KYOCERA SGS PRECISION TOOLS, INC., AND DECLARING AN EMERGENCY.

WHEREAS, on March 10, 2014, Council passed Ordinance No. 20-2014, authorizing the Mayor to enter into an Enterprise Zone Tax Incentive Agreement with SGS Tool Company & Crooked River Realty, LLC/Haag Investments and the County of Summit, to provide real property tax abatement; and

WHEREAS, Kyocera SGS Precision Tools, Inc. recently purchased SGS Tool Company & Crooked River Realty, LLC/Haag Investments and the Enterprise Zone Tax Incentive Agreement approved by Council should be amended to reflect the name change and to comply with state law; and

WHEREAS, Kyocera SGS Precision Tools, Inc. agrees to abide by the same terms and conditions set forth in the Enterprise Zone Agreement previously approved by City Council.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit, and State of Ohio, that:

Section 1. The Enterprise Zone Tax Incentive Agreement is hereby amended to change the company name from SGS Tool Company & Crooked River Realty, LLC/Haag Investments to Kyocera SGS Precision Tools, Inc. consistent with the terms in the Enterprise Zone Application and Enterprise Zone Tax Incentive Agreement previously approved by Council.

Section 2. Council further authorizes the Mayor, Director of Finance, Director of Community Development, Director of Law and any other City officials, individually and/or collectively as may be appropriate, to prepare and execute such other documents and do other things as are necessary for and incidental to carrying out the requirements of this legislation.

Section 3. Any other ordinances or resolutions or portions of ordinances and resolutions inconsistent herewith are hereby repealed, but any ordinances and resolutions not inconsistent herewith and which have not previously been repealed are hereby ratified and confirmed.

It is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Chapter 107 of the Codified Ordinances.

Section 5. This ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga falls and the inhabitants thereof, and provided it receives the affirmative vote of two-thirds of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force at the earliest period allowed by law.
