6 ORDINANCE NO. 74 - 2016

8 AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER  
9 INTO A CONTRACT OR CONTRACTS, WITHOUT  
10 COMPETITIVE BIDDING, WITH MOTOROLA SOLUTIONS FOR  
11 THE LEASE AND/OR PURCHASE OF REPLACEMENT  
12 PORTABLE RADIOS AND ALL NECESSARY ACCESSORIES  
13 FOR USE BY THE POLICE DEPARTMENT, AND  
14 DECLARING AN EMERGENCY.

15  
16 WHEREAS, the Police Department proposes to replace all portable radios, and;

17  
18 WHEREAS, the operability of police emergency radio communications is critical  
19 to the safety of the public and police employees; and

20  
21 WHEREAS, the quote received from Motorola Solutions includes an additional  
22 discount, which is below the pricing on the state bid list.

23  
24 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga  
25 Falls, County of Summit and State of Ohio, that:

26  
27 Section 1. The Mayor is hereby authorized to enter into a contract or contracts,  
28 without competitive bidding, with Motorola Solutions, for the lease and/or purchase of  
29 portable radios and all necessary accessories.

30  
31 Section 2. The Director of Finance is hereby authorized and directed to make  
32 payment for same from the Capital Projects Fund, line item Capital Outlay.

33  
34 Section 3. Any other ordinances and resolutions or portions of ordinances and  
35 resolutions inconsistent herewith are hereby repealed, but any ordinances and  
36 resolutions or portions of ordinances and resolutions not inconsistent herewith and  
37 which have not previously been repealed are hereby ratified and confirmed.

39 Section 4. It is found and determined that all formal actions of this Council  
40 concerning and relating to the adoption of this ordinance were adopted in an open  
41 meeting of this Council and that all deliberations of this Council and of any of its  
42 committees that resulted in such formal action were in meetings open to the public, in  
43 compliance with all legal requirements including Section 121.22 of the Ohio Revised  
44 Code.

45  
46 Section 5. That this ordinance is hereby declared to be an emergency measure  
47 necessary for the preservation of the public peace, health, safety, convenience and  
48 welfare of the City of Cuyahoga Falls and the inhabitants thereof, and provided it  
49 receives the affirmative vote of two-thirds of the members elected or appointed to  
50 Council, it shall take effect and be in force immediately upon its passage and approval

51 by the Mayor; otherwise it shall take effect and be in force at the earliest period  
52 allowed by law.
