AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT, WITHOUT COMPETITIVE BIDDING, WITH BASIC NEO FOR THE ADMINISTRATION OF THE SECTION 125 FLEXIBLE SPENDING ACCOUNT PLAN, HEALTH REIMBURSEMENT ACCOUNT PLAN, HEALTH SAVINGS ACCOUNT PLAN, RETIREE MEDICAL REIMBURSEMENT ACCOUNT PLAN AND COBRA, FOR A PERIOD NOT TO EXCEED THREE YEARS, AND DECLARING AN EMERGENCY.

BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit and State of Ohio, that:

Section 1. The Mayor is hereby authorized to enter into a contract or contracts, without competitive bidding, with BASIC NEO, on the basis of its final proposals dated October 5, 2017, for the professional services necessary to conduct the administration of the Section 125 Flexible Spending Account Plan, Health Reimbursement Account Plan, Health Savings Account Plan, Retiree Medical Reimbursement Account Plan and COBRA, for contract periods not to exceed three years.

Section 2. The Director of Finance is hereby authorized to pay approved invoices for work based upon the Contract, from the Self-Insurance Fund.

Section 3. Any other ordinances or resolutions or portions of ordinances and resolutions inconsistent herewith are hereby repealed, but any ordinances and resolutions not inconsistent herewith and which have not previously been repealed are hereby ratified and confirmed.

Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, to the extent applicable, including Chapter 107 of the Codified Ordinances.
