Miscellaneous Business

Ms. Colavecchio passed out a hard copy of the fourth quarter economic development report summarizing all the economic activity tracked through 2022. The portion highlighted in bold print indicates that nine more jobs were created in 2022 than in 2021. In 2022, there was also an increase in development in the City of \$14,448,000 over 2021. Ms. Colavecchio stated that she had a meeting this afternoon with Mr. Mitch Pachta, owner of the Cashmere Cricket, and he is the new lessee of Tommy Bruno building owned by John Chlebina and currently under construction. The building will have a bar located on the top floor and a speakeasy located on the bottom floor. It is going to be called Vacancy and is expected to be open by August 1st. She also passed out a flyer from the NECCO Department requesting sponsorships for Downtown Friday events.

Mayor Walters stated that they are in the fifth year of the Downtown revitalization, and, in order to celebrate its success, there will be fifth birthday celebration held from August 7th to 13th. Every evening will be packed with events. Among other things, he did put in a request for an appearance of the Weinermobile.

Mr. Balthis stated that he likes the name of the new bar, because, the way things are going, it is going to be the only vacancy on Front Street.
