ORDINANCE NO. /// -2021

AN ORDINANCE APPROPRIATING \$1,309,632 OF COMMUNITY DEVELOPMENT BLOCK GRANT CARRYOVER FUNDS FOR CALENDAR YEAR 2021, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Cuyahoga Falls is the recipient of Community Development Block Grant ("CDBG") funds through the Department of Housing and Urban Development; and

WHEREAS, the City of Cuyahoga Falls has available CDBG carryover funds, in the amount of \$1,309,632; and

WHEREAS, it is necessary to appropriate these carryover funds from calendar year 2020 to fund calendar year 2021 program operations; and

WHEREAS, this Council finds and determines after reviewing all pertinent information, that the aforementioned appropriations in the amount of \$1,309,632 are necessary and in the best interest of the City of Cuyahoga Falls;

NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Cuyahoga Falls, County of Summit, State of Ohio, that:

<u>Section 1.</u> The Director of Finance is hereby authorized to increase appropriations in the CDBG Fund, line item, Other Operations, by \$1,254,292 and CDBG line item Personal Services by \$55,340 and make payments from the same.

<u>Section 2.</u> Any ordinance or resolutions or portions of ordinances and resolutions inconsistent herewith are hereby repealed, but any ordinances and resolutions not inconsistent herewith and which have not previously been repealed are hereby ratified and confirmed.

Section 3. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements including Chapter 107 of the Codified Ordinances.
