## CITY OF CUYAHOGA FALLS, OHIO

ORDINANCE NO. 15 - 2023

AN ORDINANCE AUTHORIZING THE PARKS AND RECREATION BOARD TO ENTER INTO A CONTRACT OR CONTRACTS, WITHOUT COMPETITIVE BIDDING, WITH DAN GUARDO CONTRACTING, INC., FOR THE WATER WORKS FAMILY AQUATIC CENTER POOL SURFACE REFINISH PROJECT, AND DECLARING AN EMERGENCY.

WHEREAS, the pool surface at Water Works Family Aquatic Center is now over 20 years old and is reaching its effective life cycle; and

WHEREAS, Dan Guardo Contracting, Inc. will complete the resurfacing in an expedited and good workmanlike manner ensuring the resurfacing project will occur in months which Water Works Family Aquatic Center is closed so that there is no disruption to the seasonal operations; and

WHEREAS, Dan Guardo Contracting, Inc. has completed several pool resurfacing projects at Water Works Family Aquatic Center and the Natatorium and has expertise in Diamond Brite pool resurfacing; and

WHEREAS, the resurfacing, with proper application and maintenance, will afford the pool surface another 20 years of life expectancy.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit and State of Ohio, that:

<u>Section 1.</u> The Parks and Recreation Board is hereby authorized to enter into a contract or contracts, without competitive bidding, with Dan Guardo Contracting, Inc., for the Water Works Family Aquatic Center pool surface refinish project.

<u>Section 2.</u> The Finance Director is hereby authorized to make payment for same from the Recreation Levy Fund, line item Capital Outlay.

<u>Section 3.</u> Any other ordinances and resolutions or portions of ordinances and resolutions inconsistent herewith are hereby repealed, but any ordinances and resolutions or portions of ordinances and resolutions not inconsistent herewith and which have not previously been repealed are hereby ratified and confirmed.

Section 4. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in

compliance with all legal requirements, to the extent applicable, including Chapter 107 of the Codified Ordinances.

Section 5. This ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga Falls and the inhabitants thereof, and provided it receives the affirmative vote of two-thirds of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force at the earliest period allowed by law.
