7 AN ORDINANCE APPROPRIATING COMMUNITY
8 DEVELOPMENT BLOCK GRANT COVID-19 FUNDS,
9 IN THE AMOUNT OF \$233,720 FOR THE
10 COMMUNITY DEVELOPMENT BLOCK GRANT
11 FUND, AND DECLARING AN EMERGENCY.

13 WHEREAS, the City of Cuyahoga Falls has been awarded a third round of Community
14 Development Block Grant (CDBG) COVID-19 funds to facilitate programs that will help ease the
15 economic burden of low-to-moderate income individuals within the City; and
16

17 WHEREAS, it is necessary to appropriate the aforementioned funds in the amount of
18 \$233,720 in the CDBG Fund in order for the Department of Community Development to fund
19 projects and meet timeliness with the Department of Housing and Urban Development.
20

21 NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Cuyahoga Falls, County
22 of Summit, and State of Ohio that:


24 Section 1. The Director of Finance is hereby authorized to increase appropriations in the
25 Community Development Block Grant Fund, Line Item Other Operations by \$233,720 and make
26 payment from the same.

28 Section 2. Any other ordinances and resolutions or portions of ordinances and resolutions
29 inconsistent herewith be and the same are hereby repealed, but any ordinances and resolutions
30 or portions of ordinances and resolutions not inconsistent herewith and which have not
31 previously been repealed are hereby ratified and confirmed,


33 Section 3. It is found and determined that all formal actions of this Council and concerning
34 and relating to the adoption of this ordinance were adopted in an open meeting of this Council,
35 and that all deliberations of this Council and of its committees that resulted in such formal
36 action, were in meetings open to the public, in compliance with all legal requirements, to the
37 extent applicable, including Chapter 107 of the Codified Ordinances.
38

39 Section 4. This ordinance is hereby declared to be an emergency measure necessary for the
40 preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga
41 Falls and the inhabitants thereof, and provided that it receives the affirmative vote of two-thirds
42 of the members elected or appointed to Council, it shall take effect and be in force immediately
43 upon its passage and approval by the Mayor; otherwise it shall take effect and be in force at the
44 earliest period allowed by law.
