### **Miscellaneous Business**

Mr. James stated that, back in early to mid-2000s and again since 2017, it has been a pleasure to work with Mr. Gorbach. He stated that they are going to miss his wit, good humor, efficiency, and the pertinent questions that he always asked. It is not going to be the same without him.

Ms. Nichols-Rhodes stated it has been an honor to serve on Council with Mr. Gorbach. He has a great sense of humor, is intelligent, has a great institutional knowledge and has been extremely helpful to all of them. He truly is a public servant and he works hard for people. He is a person of integrity and will be missed.

Mayor Walters stated that it was an amazing ride. When he started in 2001, what sticks out in his mind is Parcel 108 where the stage and the pavilion are now located. That was controversial at the time. They were on Council, and there were several concerns and heated discussions, and it turned out genuinely nice. People also do not know that before the Municipal Court left Cuyahoga Falls, Mr. Gorbach was tasked with brokering a deal with the powers that be. It has been a pleasure serving with him all these years.

Mr. Tom Sullivan, 447 Tallmadge Road, stated that he remembers when Mr. Gorbach worked in the Tax Department. The City is not going to be the same without him. Aside from Mr. James, he is one of the only ones that have been here longer than him. There is a lot to be said for the amount of experience he has. No one at the rail knew what Budget was like until Mr. Gorbach showed everyone how to do it, because it went it from a four-to-five-hour night to the streamlined process it is now.

Mr. Ashton thanked Mr. Gorbach. He has served on Council the least amount of time of time, but Mr. Gorbach has truly taught him what it is like to be a Councilperson and to not be afraid to ask hard questions and challenge everyone to think harder. He has been an excellent shepherd of this city and his leadership will be missed.

Ms. Colavecchio stated that they have all known each other about 20 years. The Mayor and she and Mr. James go back a long time. She appreciates what Mr. Gorbach has done for the Community Development Department. He has been a great consultant. She speaks for everyone on the rail that

when they bring large projects down to Council, in the back of their minds, they would ask themselves what Mr. Gorbach is going to think of it, what is he going to do and what constructive criticism he will offer.

Mr. Brillhart stated that he is going to miss Mr. Gorbach. He has been an exemplary Councilperson and he has enjoyed serving with him. He was also his neighbor years ago and he was exemplary as a neighbor.

Ms. Loza thanked Mr. Gorbach for the leadership that he has shown her in her few years on Council. He is going to be missed.

Mr. Hoffman stated that he would like to thank Mr. Gorbach for the years he had been Finance Chair and for being able to work with him on the budget and allowing it to run smoothly. They had a good working relationship so that they had the best piece of legislation that was presented at Council and that worked for the citizens of Cuyahoga Falls.

Ms. Ciotola thanked Mr. Gorbach for his great service to the City and to the Law Department. She had the pleasure of meeting him when she came to the city in 2014. His reputation preceded him and everyone told her how wonderful, intelligent and witty he was, and he stood up to that reputation. When preparing legislation, she often asks herself what questions Mr. Gorbach is going to ask and stay lates and spends extra hours making sure she will be able to answer them. He kept her on her toes. She treasures their friendship and wishes him the best.

Mr. Balthis stated that it has been a pleasure to know Mr. Gorbach for over 20 years. The amount that he has contributed to Council is hard to express. Being one of the people who, like the Mayor, has had experience serving with him on Council and on the Administration, he has his cell phone number for those that do not have it, and plans on still calling him about things going on and getting his thoughts, because there is no question the City is a better place because of him and the work that he has done.

Mr. Gorbach stated that his wife is at her first Council meeting tonight. If she is tearing up, it is because he is going to be home on Monday nights. He came back once and he can come back again; just let him know. He appreciates what everyone has said. It has been a pleasure to be back, They definitely are all doing what they feel is best for the City. Regardless of where they land on a piece of legislation, everybody has to look in the mirror and say that their duty is what they felt was best for Cuyahoga Falls. He stated that he loved budget nights because he loved seeing the second wave. They all know the Administration; typically, they call them right away, but they do not often see the management levels below and all the hard work that they do. It is nice to put faces to names and get into the nitty-gritty of what they are thinking, and they represent themselves well with all the professionalism and all the hard work.

Mr. Gorbach moved to adjourn, second by Mr. James. Motion passed, voice vote (11-0).
