<u>Section 3.</u> In order to ensure public health and safety and in accordance with R.C. §4301.82(F)(1)(b), the number, spacing, and type of signage designating the DORA boundary shall be as set forth on page 3 of Exhibit A.

Section 4. The DORA encompasses not fewer than four (4) qualified permit holders, all of which are identified in Section V of Exhibit A, by business name, address, liquor permit type and liquor permit number. Also included in Section III of Exhibit A and in accordance with R.C. §4301.82(F)(1)(c), are the hours of operation for the DORA, which will apply to all activities within the DORA, only as may be limited or suspended by approval of City special event planning or at the request of City safety forces. Hours of operation shall be Sunday through Saturday from the hours of 10:00 am to 10:00 pm.

 <u>Section 5.</u> The Public Health and Safety Plan as described in Section VII of Exhibit A, is hereby approved as meeting the requirements of R.C. §4301.82(F)(1)(d), including the manner in which the number of personnel needed to carry out the plan shall be determined.

Section 6. The Sanitation Plan that will help maintain the appearance and public health of the area as described in Section VII of Exhibit A is hereby approved as meeting the requirements of R.C. §4301.82(F)(1)(e) and 4301.82(F)(1)(f), including the manner in which the number of personnel needed to carry out the plan shall be determined.

Section 7. As is required by R.C. §4301.82(F)(1)(g), beer, wine and intoxicating liquor shall only be served in plastic cups which shall be provided by the qualified permit holders in a readily-identified 16-ounce clear recyclable cup that identifies the DORA approved labeling. These cups and labeling will be purchased from the Downtown Partnership by the permit holders.

<u>Section 8.</u> The Clerk of Council is hereby instructed to forward a copy of this Ordinance to the Ohio Division of Liquor Control and to the investigative unit of the Ohio Department of Public Safety, all in accordance with R.C. §4301.82(C) and 4301.82(F)(3).

<u>Section 9.</u> The Director of Law is hereby authorized to make any necessary corrections to the application to comply with this ordinance or State Law.

<u>Section 10.</u> Any other ordinances or resolutions or portions of ordinances and resolutions inconsistent herewith are hereby repealed, but any ordinances and resolutions not inconsistent herewith and which have not previously been repealed are hereby ratified and confirmed.

Section 11. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, to the extent applicable, including Chapter 107 of the Codified Ordinances.



#### I. INTRODUCTION AND SUBMITTAL OF APPLICATION

Section 4301.82 of the Ohio Revised Code (ORC) authorizes municipalities over 50,000 in population to create a Designated Outdoor Refreshment Area or "DORA" up to 640 acres. In order to consider the creation of a DORA, the Executive Officer of the City of Cuyahoga Falls must file an application with the Cuyahoga Falls City Council (City Council), which meets certain statutory requirements. The application filing must be advertised for two consecutive weeks in a newspaper of general circulation. Not earlier than 30 days, but not later than 60 days, after the initial publication of the notice, the City Council may approve or disapprove of the application by ordinance or resolution.

The creation of the DORA is intended to serve as an economic tool to attract patrons to downtown Cuyahoga Falls and highlight the area as a destination for dining and entertainment. The purpose of this application is to request City Council approve a DORA in Cuyahoga Falls.

The Downtown Cuyahoga Falls Partnership initiated the request for a DORA after it received multiple requests for it from its partner and volunteer base. All participating liquor permit establishments will be required to execute an agreement with the Partnership stating that the establishment will purchase 16-ounce clear recyclable cups for and the identifying stickers for DORA cups from the Partnership. The Partnership will also be purchasing door decals for all establishments within the proposed DORA boundary. The door decals will allow patrons to recognize which establishments are selling DORA drinks and whether retail establishments will allow DORA cups on their premises.

The Downtown Cuyahoga Falls Partnership will be responsible for administering any DORA related materials, including DORA cups and DORA stickers. Any participating business with a liquor permit will be required to enter into an agreement with the Downtown Cuyahoga Falls Partnership for the provision of these supplies.

#### II. BOUNDARIES

In accordance with O.R.C. 4301.82(B)(1)(a), the boundaries of the DORA are depicted on the following map and described as follows. A list of the street addresses within the DORA are also attached. The City of Cuyahoga Falls is a chartered municipal corporation with a population of 51,114 (2020 Census Data).



## **Signage Defining Boundaries of DORA**

The City will supply Entrance/Exit signs to the DORA at the major access points on Front Street, Second Street, Portage Trail, and Broad Boulevard.

## III. HOURS OF OPERATION

The DORA be operable Sunday through Saturday from 10 am until 10 pm.

## IV. NATURE OF ESTABLISHMENTS

In accordance with O.R.C. 4301.82(B)(2), the nature and type of establishments that will be located within the DORA are listed below.



#### VII. PUBLIC HEALTH AND SAFETY

#### **Ensuring Compliance with Minor Liquor Laws:**

It will be the responsibility of the qualified permit holder to enforce all applicable liquor laws, including minor liquor laws.

#### **Outdoor Trash and Litter Control:**

City of Cuyahoga Falls staff would be responsible for trash collection in the DORA. Recycle containers will be available to dispose of the recyclable DORA cups. Staffing levels, trash cans and recyclable bins would be monitored and adjusted as needed. Businesses in the DORA will be encouraged to provide their own recycle containers for DORA cups as well.

#### **Special Events:**

The City of Cuyahoga Falls requires that each special event using City property receive a permit from the City. As is the City's practice, each event will be reviewed as required in the Codified Ordinances of the City of Cuyahoga Falls. Permit requirements may differ between events depending on their size, layout, use of right of way, and program. However, each event will be reviewed to ensure that adequate sanitation, signage, and public safety requirements are established. The necessity of portable bathrooms, handicap accessibility, pedestrian mobility, police, fire and emergency medical ingress and egress, crowd control, DORA boundary management and trash management (dumpsters, cans, pick-up, etc.) will be addressed. Event organizers may be required to pay for special duty officers or overtime for public service or safety workers if necessary, to ensure adequate health, public and safety requirements. If the special event includes the sale of alcoholic beverages, the event organizers can request that the City suspend the DORA for the duration of the special event. Special events where the DORA will be suspended or modified include the Irish Festival, Festa Italiana, and Oktoberfest and any other city sponsored events as deemed necessary.

#### City of Cuyahoga Falls DORA Safety Plan:

The Safety Plan will help maintain public safety within the DORA, and designate the number of personnel needed to execute the Safety Plan. This will be accomplished in the following manner.

Current Public Safety personnel are adequate to maintain public safety within the DORA district. The City of Cuyahoga Falls Police Department (CFPD) currently has the ability and manpower which will enable it to maintain public safety within the DORA to include the Front Street business district. CFPD has flexibility when deploying resources and has years of experience dealing with all of the downtown events.

#### **Staffing for DORA would consist of:**

- 1. Utilizing the current scheduled shifts of Cuyahoga Falls Safety Forces giving them the ability to actively patrol the DORA and have a visible presence in the assigned area.
- 2. During pre-planned or known special events that will increase the activity in the DORA area the CFPD will seek to have the organizations involved with the event help supplement the manning needed to effectively police the DORA area. CFPD will seek payment from such organizations for extra duty officer(s) as needed. The officer(s) primary responsibility would be the Front Street area where the DORA is located.
- 3. All Safety Forces supervisors or OIC's (Officer's in Charge) have the flexibility to call in additional staffing for emergency situations or if large crowds start to get out of control.

#### **Amendments and Possible Revocation:**

City staff, business leaders, Downtown Cuyahoga Falls Partnership representatives, elected officials (including but not limited to the Ward councilpersons of the DORA area), and City residents located in the DORA would regularly meet to discuss the impacts of the DORA and recommend potential changes to Council including hours and days of operation up to and including the possible revocation of the DORA if its negatives are considered to outweigh its benefits or if it is no longer considered to be an economic benefit to the City. Council will have the final say in enacting any changes to the DORA.
