ORDINANCE NO.

AN ORDINANCE AUTHORIZING AND APPROVING THE FINAL SUBDIVISION PLAT FOR PLAZA AT CHAPEL HILL - THIRD REPLAT LOCATED ON THE SOUTH SIDE OF HOWE AVENUE BETWEEN MAIN STREET, AND CENTER DRIVE AND DECLARING AN EMERGENCY.

WHEREAS, the Charter of the City of Cuyahoga Falls requires that all decisions made by the Planning Commission be submitted to Council; and

WHEREAS, the Planning Commission is required to review and provide a recommendation for all Final Subdivision Plans in the City of Cuyahoga Falls, Ohio; and

WHEREAS, on May 3, 2022, the Planning Commission approved the Plaza at Chapel Hill Final Subdivision Plat - Third Replat consisting of developed commercial lots, general utility and access easements located on the south side of Howe Avenue between Main Street and Center Drive, within the City of Cuyahoga Falls, Ohio, as detailed in File FMP-22-00017.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit, and State of Ohio:

Section 1. That the City Council approves the Plaza at Chapel Hill Final Subdivision Plat - Third Replat consisting of developed commercial lots, general utility and access easements located on the south side of Howe Avenue between Main Street and Center Drive, within the City of Cuyahoga Falls, Ohio, in accordance with all Cuyahoga Falls General Development Code regulations and as stipulated in the Codified Ordinances of the City of Cuyahoga Falls as approved by the Planning Commission as per all plans and stipulations contained in Project File FMP-22-00017.

Section 2. That any other ordinances or resolutions or portions of ordinances and resolutions inconsistent herewith be and the same are hereby repealed, but any ordinances and resolutions not inconsistent herewith and which have not previously been repealed are hereby ratified and confirmed.

That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action, were in meetings open to the public, in compliance with all legal requirements, to the extent applicable, including Chapter 107 of the Codified Ordinances.

That this ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga Falls and the inhabitants thereof and provided it receives the affirmative vote of two thirds of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force at the earliest period allowed by law.
