8 AN ORDINANCE AUTHORIZING ALL ACTIONS NECESSARY TO ACCEPT  
9 NORTHEAST OHIO PUBLIC ENERGY COUNCIL 2021 ENERGIZED  
10 COMMUNITY GRANT FUNDS FOR ENERGY EFFICIENCY OR ENERGY  
11 INFRASTRUCTURE PROJECTS, AND DECLARING AN EMERGENCY.

13 WHEREAS, the City of Cuyahoga Falls, Ohio is a member of the Northeast Ohio Public Energy Council  
14 (NOPEC) and is eligible for the NOPEC Energized Community Grant for 2021 as provided for in the NOPEC  
15 grant program guidelines; and

17 WHEREAS, this grant will facilitate energy efficiency or energy infrastructure projects within the City  
18 of Cuyahoga Falls; and

20 WHEREAS, the City has previously entered into a Grant Agreement with NOPEC, Inc. on June 12, 2020  
21 to receive one or more NOPEC Energized Community Grant(s).

23 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit,  
24 and State of Ohio, that:



26 Section 1. The Mayor is hereby authorized to accept Northeast Ohio Public Energy Council (NOPEC)  
27 2021 Energized Community Grant Funds for energy efficiency or energy infrastructure projects.  
28 Furthermore, the Mayor, Director of Public Service, Director of Law and other necessary City officials are  
29 authorized to provide such other information and to execute such other documents and do all other actions  
30 as are necessary for and incidental to carrying out the requirements of this ordinance and the terms of the  
31 Grant Agreement.



33 Section 2. Any other ordinances or resolutions or portions of ordinances and resolutions inconsistent  
34 herewith are hereby repealed, but any ordinances and resolutions not inconsistent herewith and which  
35 have not previously been repealed are hereby ratified and confirmed.

37 Section 3. It is found and determined that all formal actions of this Council concerning and relating to  
38 the adoption of this ordinance were adopted in an open meeting of this Council, and that all deliberations  
39 of this Council and of any of its committees that resulted in such formal action, were in meetings open to  
40 the public, in compliance with all legal requirements, to the extent applicable, including Chapter 107 of the  
41 Codified Ordinances.



43 Section 4. This ordinance is hereby declared to be an emergency measure necessary for the preservation  
44 of the public peace, health, safety, convenience and welfare of the City of Cuyahoga Falls and the  
45 inhabitants thereof, and provided it receives the affirmative vote of two thirds of the members elected or  
46 appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the  
47 Mayor; otherwise it shall take effect and be in force at the earliest period allowed by law.
