An ordinance to approve current replacement pages to the Cuyahoga Falls Codified Ordinances, and declaring an emergency.

Mr. Matt Dickinson, Deputy Law Director, presented Temporary Ordinance B-72 to Council. Certain provisions within the Codified Ordinances should be amended to conform with current State law as required by the Ohio Constitution, Various ordinances of a general and permanent nature have been passed by Council which should be included in the Codified Ordinances. The City has heretofore entered into a contract with the Walter H. Drane Company to prepare and publish such revision which is before Council.

The ordinances of the City of Cuyahoga Falls, Ohio, of a general and permanent nature, as revised, recodified, rearranged and consolidated into component codes, titles, chapters and sections within the 2022 Replacement Pages to the Codified Ordinances will be approved and adopted. The following sections and chapters will be added, amended or repealed as respectively indicated in order to comply with current State law:

- **549.16** Possessing Replica Firearm in School. (Amended)
