WHEREAS, the CDBG Loan and Grant Review Committee initially authorized the rehabilitation of a home at 1321 Anderson Rd., Cuyahoga Falls, Ohio 44221, as part of the CDBG Minor Housing Rehabilitation Program, in an amount not to exceed \$32,290.00, to be completed by Pro-Construction & Renovation, LLC; and

WHEREAS, the contractor, Pro-Construction & Renovation, LLC, will exceed the statutory amount for the program year 2023 and requires Council approval.

NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Cuyahoga Falls. County of Summit, and State of Ohio that:

Section 1. The City is authorized to procure Pro-Construction & Renovation, LLC to
