The Park and Recreation Board is hereby authorized to enter into a 28 contract or contracts, after publicly advertising for bids, for the interior renovation of 29 Brookledge Golf Club Clubhouse. 30 31 Section 2. The Director of Finance is hereby authorized and directed to make

payment for the same from the Recreation Levy Fund, line item, Capital Outlay.
