7 AN ORDINANCE AUTHORIZING THE MAYOR, AS DIRECTOR OF
8 PUBLIC SAFETY, TO ENTER INTO A CONTRACT OR CONTRACTS,
9 WITHOUT COMPETITIVE BIDDING, WITH ATLANTIC
10 EMERGENCY SOLUTIONS, INC. FOR THE PURCHASE OF SELF-
11 CONTAINED BREATHING APPARATUS (SCBA) EQUIPMENT FOR
12 USE BY THE FIRE DEPARTMENT, AND DECLARING AN
13 EMERGENCY.

15 BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit and State
16 of Ohio, that:
17

18 Section 1. The Mayor, as Director of Public Safety, is hereby authorized to enter into a
19 contract or contracts, without competitive bidding, with Atlantic Emergency Solutions, Inc., for
20 the purchase of fifty-eight (58) SCBAs and related equipment for use by the Fire Department.
21

22 Section 2. The Director of Finance is hereby authorized to make payment for same from the
23 Capital Projects Fund, line-item Capital Outlay.

25 Section 3. Any other ordinances or resolutions or portions of ordinances and resolutions
26 inconsistent herewith are hereby repealed, but any ordinances and resolutions not inconsistent
27 herewith and which have not previously been repealed are hereby ratified and confirmed.
28

29 Section 4. It is found and determined that all formal actions of this Council concerning and
30 relating to the adoption of this ordinance were adopted in an open meeting of this Council, and
31 that all deliberations of this Council and of any of its committees that resulted in such formal
32 action, were in meetings open to the public, in compliance with all legal requirements, to the
33 extent applicable, including Chapter 107 of the Codified Ordinances.

35 Section 5. This ordinance is hereby declared to be an emergency measure necessary for the
36 preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga
37 Falls and the inhabitants thereof and provided it receives the affirmative vote of two-thirds of the
38 members elected or appointed to Council, it shall take effect and be in force immediately upon
39 its passage and approval by the Mayor; otherwise it shall take effect and be in force at the earliest
40 period allowed by law.
