## **Miscellaneous Business**

Mr. Brillhart stated that, about 10 years ago, he bought a new refrigerator that has a filter that required replacing every three months. He noticed that this March, he did not have to replace it. He contacted Mr. Russ Kring, Water Utilities Superintendent, to see when the new filters were installed at the water plant and was told that they have been installed. He noted that the water is also now a little bit softer and his car does not spot after not drying it immediately after washing. Not having to replace the filter in his refrigerator saved him \$45 and they are using less soap. In this time of everything going up, Cuyahoga Falls is saving people money. This is the fruit of Council passing legislation last year for the Water Department.
