9 AN ORDINANCE AUTHORIZING THE PARKS AND RECREATION
10 BOARD TO ENTER INTO A CONTRACT, WITH SAFE SLIDE
11 RESTORATION FOR WATER SLIDE PAINT AND REPAIRS AT
12 WATER WORKS FAMILY AQUATIC CENTER, AND DECLARING AN
13 EMERGENCY.

16 WHEREAS, Water Works Family Aquatic Center fiberglass slides are now over 20 years old
17 and are reaching their effective life cycle; and
1819 WHEREAS, Safe Slide Restoration has completed slide repairs at Water Works Family Aquatic
20 Center in the past and has expertise in water park fiberglass slide painting and repairs.
2122 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County
23 of Summit and State of Ohio, that:
2425 Section 1. The Parks and Recreation Board is hereby authorized to enter into a contract or
26 contracts, with Safe Slide Restoration for water slide paint and repairs at Water Works Family
27 Aquatic Center.
2829 Section 2. The Director of Finance is hereby authorized to make payment for same from
30 Recreation Levy Fund, line item Capital Outlay.
3132 Section 3. Any other ordinances and resolutions or portions of ordinances and resolutions
33 inconsistent herewith are hereby repealed, but any ordinances and resolutions or portions of
34 ordinances and resolutions not inconsistent herewith and which have not previously been
35 repealed are hereby ratified and confirmed.
3637 Section 4. It is found and determined that all formal actions of this Council concerning
38 and relating to the adoption of this ordinance were adopted in an open meeting of this Council
39 and that all deliberations of this Council and of any of its committees that resulted in such formal
40 action were in meetings open to the public, in compliance with all legal requirements including
41 Chapter 107 of the Codified Ordinances.
4243 Section 5. This ordinance is hereby declared to be an emergency measure necessary for
44 the preservation of the public peace, health, safety, convenience and welfare of the City of
45 Cuyahoga Falls and the inhabitants thereof, and provided it receives the affirmative vote of
46 two-thirds of the members elected or appointed to Council, it shall take effect and be in force
47 immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in
48 force at the earliest period allowed by law.
