



5 ORDINANCE NO. 77 - 2025
67 AN ORDINANCE AUTHORIZING THE DIRECTOR OF
8 PUBLIC SERVICE TO EXECUTE A MODIFICATION OF
9 CONTRACT NO. 9075 WITH KENMORE CONSTRUCTION
10 COMPANY, INC., FOR THE SOUTH FRONT STREETSCAPE
11 PROJECT, AND DECLARING AN EMERGENCY.

1314 WHEREAS, under the authority of Ordinance 52-2024, the City, after competitive
15 bidding, entered into contract No. 9075 with Kenmore Construction Company, Inc., for
16 the purposes of executing the South Front Streetscape project; and
1718 WHEREAS, pursuant to the authority of Section 181.06 of the Codified Ordinances,
19 the City entered into a first modification of said contract on or about November 27, 2024;
20 and
2122 WHEREAS, it is necessary to adjust the unit quantities of labor and material in the
23 contract beyond what was originally estimated, in order to meet the needs of the City in
24 executing the South Front Streetscape project, which will increase the estimated total
25 contract price by an amount not exceeding \$241,656.16;
2627 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls,
28 County of Summit and State of Ohio:
2930 Section 1. The Director of Public Service is hereby authorized to execute a
31 modification of Contract No. 9075 with Kenmore Construction Company, Inc., for the
32 South Front Streetscape project.
3334 Section 2. The Director of Finance is hereby authorized to make payment for same
35 from the Capital Project Fund, line item Capital Outlay.
3637 Section 3. Any other ordinances or resolutions or portions of ordinances and
38 resolutions inconsistent herewith be and the same are hereby repealed, but any
39 ordinances and resolutions not inconsistent herewith and which have not previously been
40 repealed are hereby ratified and confirmed.
4142 Section 4. It is found and determined that all formal actions of this Council
43 concerning and relating to the adoption of this ordinance were adopted in an open
44 meeting of this Council, and that all deliberations of this Council and of any of its
45 committees that resulted in such formal action, were in meetings open to the public, in
46 compliance with all legal requirements, to the extent applicable, including Chapter 107
47 of the Codified Ordinances.
4849 Section 5. This ordinance is hereby declared to be an emergency measure necessary
50 for the preservation of the public peace, health, safety, convenience and welfare of the
51 City of Cuyahoga Falls and the inhabitants thereof, and provided it receives the
52 affirmative vote of two thirds of the members elected or appointed to Council, it shall take
53 effect and be in force immediately upon its passage and approval by the Mayor; otherwise
54 it shall take effect and be in force at the earliest period allowed by law.
