9 AN ORDINANCE AUTHORIZING THE PARKS AND RECREATION
10 BOARD, OR ITS DESIGNEE, TO EXECUTE A MODIFICATION OF
11 CONTRACT NO. 9344, WITH SAFE SLIDE RESTORATION TO
12 PROVIDE WATER SLIDE PAINT AND REPAIRS AT WATER WORKS
13 FAMILY AQUATIC CENTER, AND DECLARING AN EMERGENCY.

16 WHEREAS, under the authority of Ordinance 62-2025 and pursuant to the authority of
17 Board of Control on or about September 29, 2025, the Parks and Recreation Board entered into
18 Contract No. 9344, with Safe Slide Restoration to provide water slide paint and repairs at Water
19 Works Family Aquatic Center; and
20

21 WHEREAS, for the project to proceed, additional work on the anchor studs and nuts are
22 required, which will increase the estimated total contract price by an amount not to exceed
23 \$109,191.00.

25 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County
26 of Summit and State of Ohio, that:
27

28 Section 1. The Parks and Recreation Board is hereby authorized to execute a modification
29 of Contract No. 9344, with Safe Slide Restoration in an increased amount not to exceed
30 \$13,804.00. The total contract price after modification as authorized herein shall not exceed
31 \$109,191.00.

33 Section 2. The Director of Finance is hereby authorized and directed to make payment for
34 same from Recreation Levy Fund, line item Capital Outlay.

36 Section 3. Any other ordinances and resolutions or portions of ordinances and resolutions
37 inconsistent herewith are hereby repealed, but any ordinances and resolutions or portions of
38 ordinances and resolutions not inconsistent herewith and which have not previously been
39 repealed are hereby ratified and confirmed.

41 Section 4. It is found and determined that all formal actions of this Council concerning
42 and relating to the adoption of this ordinance were adopted in an open meeting of this Council
43 and that all deliberations of this Council and of any of its committees that resulted in such formal
44 action were in meetings open to the public, in compliance with all legal requirements including
45 Chapter 107 of the Codified Ordinances.
46

47 Section 5. This ordinance is hereby declared to be an emergency measure necessary for
48 the preservation of the public peace, health, safety, convenience and welfare of the City of
49 Cuyahoga Falls and the inhabitants thereof, and provided it receives the affirmative vote of
50 two-thirds of the members elected or appointed to Council, it shall take effect and be in force
51 immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in
52 force at the earliest period allowed by law.
