5 ORDINANCE NO 102 - 2025

7 AN ORDINANCE AUTHORIZING THE DIRECTOR OF  
8 PUBLIC SERVICE TO ENTER INTO A CONTRACT OR  
9 CONTRACTS, ACCORDING TO LAW, FOR THE PURCHASE  
10 OF ANNUAL REQUIREMENTS OF CERTAIN MATERIALS  
11 AND SUPPLIES FOR USE BY THE SANITATION DIVISION  
12 DURING 2026, AND DECLARING AN EMERGENCY.  
13

14 BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County of Summit  
15 and State of Ohio, that:

16  
17 Section 1. The Director of Public Service is hereby authorized to enter into a contract  
18 or contracts, according to law, for the purchase of the following materials and supplies  
19 for use in the Sanitation Division during 2026:

21 Refuse Containers  
22

23 Section 2. The Director of Finance is hereby authorized to make payment for same  
24 from the Sanitation Fund, line item Other Operations.  
25

26 Section 3. Any other ordinances and resolutions or portions of ordinances and  
27 resolutions inconsistent herewith are hereby repealed, but any ordinances and  
28 resolutions or portions of ordinances and resolutions not inconsistent herewith and  
29 which have not previously been repealed are hereby ratified and confirmed.  
30

31 Section 4. It is found and determined that all formal actions of this Council  
32 concerning and relating to the adoption of this ordinance were adopted in an open  
33 meeting of this Council, and that all deliberations of this Council and of any of its  
34 committees that resulted in such formal action, were in meetings open to the public, in  
35 compliance with all legal requirements, to the extent applicable, including Chapter 107  
36 of the Codified Ordinances.  
37

38 Section 5. This ordinance is hereby declared to be an emergency measure necessary  
39 for the preservation of the public peace, health, safety, convenience and welfare of the  
40 City of Cuyahoga Falls and the inhabitants thereof and provided it receives the affirmative  
41 vote of two-thirds of the members elected or appointed to Council, it shall take effect and  
42 be in force immediately upon its passage and approval by the Mayor; otherwise it shall  
43 take effect and be in force at the earliest period allowed by law.


