7 AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER
8 INTO A NOPEC ENERGIZED COMMUNITY GRANT
9 AGREEMENT WITH NORTHEAST OHIO PUBLIC ENERGY
10 COUNCIL, INC., FOR ENERGY EFFICIENCY OR ENERGY
11 INFRASTRUCTURE PROJECTS, AND DECLARING AN
12 EMERGENCY.

14 WHEREAS, the City of Cuyahoga Falls is a member of the Northeast Ohio Public
15 Energy Council ("NOPEC") and is eligible for the NOPEC Energized Community Grant for
16 2026, as provided for in the NOPEC grant program guidelines.

18 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls,
19 County of Summit, and State of Ohio, that:

21 Section 1. The Mayor is hereby authorized to enter into a NOPEC Energized
22 Community Grant Agreement with Northeast Ohio Public Energy Council, Inc. for energy
23 efficiency or energy infrastructure projects. The Mayor, Director of Public Service,
24 Director of Law, and other necessary City officials are authorized to provide such other
25 information and to execute such other documents, and do all other actions as are
26 necessary for and incidental to carrying out the requirements of this ordinance and the
27 terms of the Grant Agreement.

29 Section 2. Any other ordinances or resolutions or portions of ordinances and
30 resolutions inconsistent herewith are hereby repealed, but any ordinances and
31 resolutions not inconsistent herewith and which have not previously been repealed are
32 hereby ratified and confirmed.

33
34 Section 3. It is found and determined that all formal actions of this Council
35 concerning and relating to the adoption of this ordinance were adopted in an open
36 meeting of this Council, and that all deliberations of this Council and of any of its
37 committees that resulted in such formal action, were in meetings open to the public, in
38 compliance with all legal requirements, to the extent applicable, including Chapter 107
39 of the Codified Ordinances.

41 Section 4. This ordinance is hereby declared to be an emergency measure necessary
42 for the preservation of the public peace, health, safety, convenience and welfare of the
43 City of Cuyahoga Falls and the inhabitants thereof, and provided it receives the
44 affirmative vote of two thirds of the members elected or appointed to Council, it shall take
45 effect and be in force immediately upon its passage and approval by the Mayor; otherwise
46 it shall take effect and be in force at the earliest period allowed by law.
