5 ORDINANCE NO. 8 - 20266
7 AN ORDINANCE APPROPRIATING COMMUNITY DEVELOPMENT
8 BLOCK GRANT CARRYOVER FUNDS FOR CALENDAR YEAR 2026,
9 AND DECLARING AN EMERGENCY.10
11 WHEREAS, the City of Cuyahoga Falls is the recipient of Community Development
12 Block Grant ("CDBG") funds through the Department of Housing and Urban
13 Development; and14
15 WHEREAS, the City of Cuyahoga Falls has available CDBG carryover funds, in the
16 amount of \$464,795; and17
18 WHEREAS, it is necessary to appropriate these carryover funds from calendar year
19 2025 to fund calendar year 2026 program operations; and20
21 WHEREAS, this Council finds and determines after reviewing all pertinent
22 information, that the aforementioned appropriations in the amount of \$464,795 are
23 necessary and in the best interest of the City of Cuyahoga Falls.24
25 NOW THEREFORE, BE IT ORDAINED, by the Council of the City of Cuyahoga Falls,
26 County of Summit, State of Ohio, that:27
28 Section 1. The Director of Finance is hereby authorized to increase appropriations in
29 the CDBG Fund, line item, Other Operations, by \$464,795 and make payments from the
30 same.31
32 Section 2. Any ordinances or resolutions or portions of ordinances and resolutions
33 inconsistent herewith are hereby repealed, but any ordinances and resolutions not
34 inconsistent herewith and which have not previously been repealed are hereby ratified
35 and confirmed.36
37 Section 3. It is found and determined that all formal actions of this Council
38 concerning and relating to the adoption of this ordinance were adopted in an open
39 meeting of this Council, and that all deliberations of this Council and of any of its
40 committees that resulted in such formal action, were in meetings open to the public, in
41 compliance with all legal requirements including Chapter 107 of the Codified Ordinances.42
43 Section 4. This ordinance is hereby declared to be an emergency measure necessary
44 of the preservation of the public peace, health, safety, convenience, and welfare of the
45 City of Cuyahoga Falls and the inhabitants thereof, and provided it receives the
46 affirmative vote of two thirds of the members elected or appointed to Council, it shall take
47 effect and be in force immediately upon its passage and approval by the Mayor; otherwise
48 it shall take effect and be in force at the earliest period allowed by law.


