7 AN ORDINANCE AUTHORIZING THE DIRECTOR OF
8 PUBLIC SERVICE TO EXECUTE A MODIFICATION OF
9 CONTRACT NO. 9481 WITH PERRIN ASPHALT COMPANY
10 FOR THE ANNUAL RESURFACING AND/OR REPAIR OF
11 VARIOUS STREETS, AND DECLARING AN EMERGENCY.

13 WHEREAS, under the authority of Ordinance 10-2026, the City, after competitive
14 bidding, entered into Contract No. 9481 with Perrin Asphalt Company, for the annual
15 resurfacing and/or repair of various streets; and

16
17 WHEREAS, due to cost savings achieved through the lowest and most responsible
18 bid, the City intends to allocate the savings toward additional repairs on various streets.

19
20 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls,
21 County of Summit and State of Ohio, that:

23 Section 1. The Director of Public Service is hereby authorized to execute a
24 modification of Contract No. 9481 with Perrin Asphalt Company for the annual
25 resurfacing and/or repair of various streets in an amount not to exceed \$500,000.00. The
26 total contract price after modification as authorized herein shall not exceed
27 \$3,899,992.90.

28
29 Section 2. The Director of Finance is hereby authorized to make payment for same,
30 in an amount not to exceed \$500,000.00, from the Capital Projects Fund, line item
31 Capital Outlay.

33 Section 3. Any other ordinances and resolutions or portions of ordinances and
34 resolutions inconsistent herewith are hereby repealed, but any ordinances and
35 resolutions or portions of ordinances and resolutions not inconsistent herewith and
36 which have not previously been repealed are hereby ratified and confirmed.

37
38 Section 4. It is found and determined that all formal actions of this Council
39 concerning and relating to the adoption of this ordinance were adopted in an open
40 meeting of this Council, and that all deliberations of this Council and of any of its
41 committees that resulted in such formal action, were in meetings open to the public, in
42 compliance with all legal requirements, to the extent applicable, including Chapter 107
43 of the Codified Ordinances.

45 Section 5. This ordinance is hereby declared to be an emergency measure necessary
46 for the preservation of the public peace, health, safety, convenience and welfare of the
47 City of Cuyahoga Falls and the inhabitants thereof and provided it receives the affirmative
48 vote of two-thirds of the members elected or appointed to Council, it shall take effect and
49 be in force immediately upon its passage and approval by the Mayor; otherwise it shall
50 take effect and be in force at the earliest period allowed by law.


