7 AN ORDINANCE AUTHORIZING THE DIRECTOR OF
8 PUBLIC SERVICE TO ENTER INTO A CONTRACT OR
9 CONTRACTS WITHOUT COMPETITIVE BIDDING WITH
10 PATRIOT ENGINEERING AND ENVIRONMENTAL, INC.
11 FOR REMOVAL OF UNDERGROUND STORAGE TANKS ON
12 FRONT STREET, AND DECLARING AN EMERGENCY.

15 WHEREAS, as authorized by Ordinance 52-2024, the South Front Streetscape project
16 is currently under construction, which requires new underground stormwater piping and
17 infrastructure to be installed; and
18

19 WHEREAS, during the excavation for this stormwater infrastructure at the locations
20 of 1816 Front Street and 1914 Front Street, multiple previously unknown underground
21 storage tanks were discovered and need to be removed in a timely manner to allow for
22 the South Front construction to progress on schedule; and

24 WHEREAS, Ohio Revised Code Section 735.051 authorizes this Council to waive
25 formal competitive bidding and advertising for contracts where there is a real and present
26 emergency arising in connection with the operation and maintenance of a municipally-
27 owned facility; and

29 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls,
30 County of Summit and State of Ohio:

32 Section 1. The Director of Public Service is hereby authorized to enter into a contract
33 or contracts without competitive bidding with Patriot Engineering and Environmental,
34 Inc. for the emergency removal of underground storage tanks on Front Street in the City
35 of Cuyahoga Falls.

37 Section 2. The Director of Finance is hereby authorized and directed to make
38 payment for same from the Capital Project Fund, line item Capital Outlay.

40 Section 3. Any other ordinances or resolutions or portions of ordinances and
41 resolutions inconsistent herewith be and the same are hereby repealed, but any
42 ordinances and resolutions not inconsistent herewith and which have not previously been
43 repealed are hereby ratified and confirmed.

45 Section 4. It is found and determined that all formal actions of this Council
46 concerning and relating to the adoption of this ordinance were adopted in an open
47 meeting of this Council, and that all deliberations of this Council and of any of its
48 committees that resulted in such formal action, were in meetings open to the public, in
49 compliance with all legal requirements, to the extent applicable, including Chapter 107
50 of the Codified Ordinances.

55 Section 5. This ordinance is hereby declared to be an emergency measure necessary
56 for the preservation of the public peace, health, safety, convenience and welfare of the
57 City of Cuyahoga Falls and the inhabitants thereof, and provided it receives the
58 affirmative vote of two thirds of the members elected or appointed to Council, it shall take
59 effect and be in force immediately upon its passage and approval by the Mayor; otherwise
60 it shall take effect and be in force at the earliest period allowed by law.
