9 AN ORDINANCE AUTHORIZING THE DIRECTOR OF
10 PUBLIC SERVICE TO ENTER INTO A CONTRACT OR
11 CONTRACTS, WITH LIVEEO, INC., FOR THE USE OF
12 SATELLITE IMAGERY TO MONITOR VEGETATION
13 GROWTH AROUND POWER LINES, AND DECLARING AN
14 EMERGENCY.
15

16 WHEREAS, the Electric Department will be utilizing satellite imagery to monitor
17 vegetation growth around power lines; and
18

19 WHEREAS, the Electric Department will use feedback from this monitoring to work with
20 line clearance contractors to proactively trim vegetation; and
21

22 WHEREAS, the Electric Department will benefit from this service by reducing electric
23 outages; and
24

25 WHEREAS, the Electric Department has contracted with LiveEO, Inc. to successfully
26 pilot this program.
27

28 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls,
29 County of Summit and State of Ohio:
30

31 Section 1. The Director of Public Service is hereby authorized to enter into a contract
32 or contracts, with LiveEO, Inc., for the use of satellite imagery to monitor vegetation
33 growth around power lines.
34

35 Section 2. The Director of Finance is hereby authorized to make payment for same
36 from the Electric Fund, line item Other Operations.
37

38 Section 3. Any other ordinances or resolutions or portions of ordinances and
39 resolutions inconsistent herewith be and the same are hereby repealed, but any
40 ordinances and resolutions not inconsistent herewith and which have not previously been
41 repealed are hereby ratified and confirmed.
42

43 Section 4. It is found and determined that all formal actions of this Council
44 concerning and relating to the adoption of this ordinance were adopted in an open
45 meeting of this Council, and that all deliberations of this Council and of any of its
46 committees that resulted in such formal action, were in meetings open to the public, in
47 compliance with all legal requirements, to the extent applicable, including Chapter 107
48 of the Codified Ordinances.
49

50 Section 5. This ordinance is hereby declared to be an emergency measure necessary
51 for the preservation of the public peace, health, safety, convenience and welfare of the
52 City of Cuyahoga Falls and the inhabitants thereof, and provided it receives the
53 affirmative vote of two thirds of the members elected or appointed to Council, it shall take
54 effect and be in force immediately upon its passage and approval by the Mayor; otherwise
55 it shall take effect and be in force at the earliest period allowed by law.
