## 6. Application Directions



### Definition/Use:

- A single story structure
- Is not insulated
- Possesses no plumbing fixtures
- Has a footprint of not more than 199 square feet\*\*
- Is used as an accessory structure - primarily storage only

### Permit Requirements:

1. Residential Shed -- Zoning Certificate Application (attached)
2. Plot Plan - Drawn to scale showing:
  - a) Property lines (and property dimensions)
  - b) All existing and proposed structures
  - c) Distance from the house to the proposed shed
  - d) North arrow
  - e) Distance from the property line to the proposed shed\*\*

**\*\*Actual maximum shed square footage is based on Table 1132-2 Residential Lot and Design Standards-Cuyahoga Falls General Development Code.**

### Design & Materials:

1. Metal Sheds -- Maximum 80 square feet with a 10 foot height.
2. Wood, Vinyl, other Planning Director approved exterior materials -- Maximum 199 square feet and 15 foot height. Over 200 square feet must follow garage requirements and must also obtain a Summit County Building Permit.

### Construction Details:

1. Elevation views (showing grade lines)
2. Building height specifications
3. Sectional views
4. Sheds must be securely anchored to the earth
5. Sheds not greater than 199 square feet may be constructed without footing or foundation, but shall be securely anchored to the earth.
