2025 DRINKING WATER CONSUMER CONFIDENCE REPORT

The City of Cuyahoga Falls has prepared the following report to provide information to you, the consumer, on the quality of our drinking water. Included within this report are general health information, water quality test results, how to participate in decisions concerning your drinking water, and water system contacts. In years prior, this report was called the Water Quality Report.

In 2025 the City of Cuyahoga Falls had an unconditioned license to operate our water system. Our goal is not just to meet the strict requirements of the EPA, but to provide treatment that surpasses these requirements in every category. To ensure that we reach this goal, Cuyahoga Falls tests the finished water frequently to ensure that all standards are met. The City of Cuyahoga Falls Water Utilities Department did not exceed any of the federally mandated maximum contaminant levels, nor did it need any variances of exemptions. Also met, were all of the requirements of our prescribed Treatment Techniques.

Source of Drinking Water

The City of Cuyahoga Falls uses well water as a source. The well field consists of 15 wells located in Water Works Park on the south bank of the Cuyahoga River. This area is part of a buried valley where permeable outwash gravels are crossed by major streams. The Cuyahoga River contributes flow to the aquifer and the well field is recharged by a series of man-made channels and lagoons.

The well field, which is the source of raw water to the water treatment plant, is surrounded by two theoretical protection zones. The "inner protection zone" is the area that provides groundwater to the City of Cuyahoga Falls' wells within one year of pumping. A chemical spill in this zone poses a greater threat to the drinking water, so this area warrants more stringent protection. The "outer protection zone" is the additional area that contributes water when the well is pumped for five years.

A Drinking Water Source Assessment, completed by the Ohio EPA for the City of Cuyahoga Falls' water system found that our source of drinking water has a high susceptibility to contamination for the following reasons:

- The sand and gravel aquifer has a depth to water ranging from 4 to 32 feet below ground surface.
- There is no low-permeability protective layer between the aquifer and the ground surface.
- Potential significant contaminant sources exist within the protection area.

A high susceptibility rating of the aquifer does not imply that the well field will become contaminated. It only means that the existing/known aquifer conditions are such that groundwater within the aquifer could become impacted if potential contaminant sources are not appropriately managed. Sources of Contamination to Drinking Water

The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity. Contaminants that may be present in source water include:

- Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.
- Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban stormwater runoff, industrial or domestic wastewater discharges, oil and gas production, mining, or farming.
- Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban stormwater runoff, and residential uses.
- Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban stormwater runoff, and septic systems.
- Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

In order to ensure that tap water is safe to drink, USEPA prescribes regulations which limit the amount of certain contaminants in water provided by public water systems. FDA regulations establish limits for contaminants in bottled water which must provide the same protections for public health.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Special Precautions

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons, such as persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infection. These people should seek advice about drinking water from their health care providers. EPA/CDC guidelines on appropriate means to lessen the

Treatment of Drinking Water

Raw water is pumped from the well field to the City of Cuyahoga Falls Water Plant. At the plant, a series of processes are used to reduce naturally occurring constituents found in the groundwater source. All of the water is discharged into iron removal filters, where chlorine is added to remove iron and manganese. Without treatment, iron and manganese may contribute to staining and mineral buildup in home water systems and can cause staining of clothing. Depending on the raw water hardness, approximately two-thirds of the iron filter effluent is softened using ion exchange softeners. This softened water effluent and the iron filter effluent that bypass the softening units are blended in the mixing tank to produce calcium carbonate (CaCo₃) with a finished hardness of 100 to 130 ppm. In this mixing chamber, chlorine, fluoride, caustic soda and orthophosphate are added.

Chlorine is added to disinfect the water. Chlorine destroys or inactivates bacteria that may be introduced into the distribution system. Coliform bacteria are generally thought of as indicator bacteria. Its presence indicates that other potentially harmful bacteria may be present. Of the 735 samples analyzed in 2025, all showed 0% presence of coliform bacteria. The use of chlorine produces disinfection byproducts called trihalomethanes (TTHMs) and haloacetic acids (HAA5). The level of TTHMs and HAA5s produced in the Cuyahoga Falls water supply can be found in the Regulated Contaminants chart. Fluoride is added for protection from tooth decay. Caustic soda and orthophosphate are added for corrosion control and pH adjustment.

Monitoring the Quality of Drinking Water

The EPA requires regular sampling to ensure drinking water safety. The Ohio EPA requires monitoring for some contaminants less than once per year because the concentrations of these contaminants do not change frequently. The information provided below covers detected contaminants that are regulated by the EPA.

Detected Contaminant Sampling

The EPA establishes the safe drinking water regulations that limit the amount of contaminants allowed in drinking water. The table shows the concentrations of detected substances found in the City of Cuyahoga Falls drinking water in comparison to regulatory limits. Substances that were tested for, but not detected, are not included in this table.

Lead Educational Information

If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. The City of Cuyahoga Falls is responsible for providing high-quality drinking water, but cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. Backflow Prevention Education for Residential Water Customers

What is backflow?

Backflow is the reversal of water flow, where possibly contaminated water flows back into the drinking water system through a cross-connection. Backflow occurs when there is a change in water pressure created by either negative pressure (a vacuum) or backpressure.

What is a cross-connection?

A cross-connection is a physical link or potential connection between a possible source of contamination and a drinking water system.

What are some examples of possible contamination sources?

- An Irrigation system may contain pesticides, herbicide, and biological organisms such as bacteria and worms, animal droppings, and other contaminants.
- Garden hoses may be submerged in swimming pools, mud puddles, utility sinks, buckets, etc. and can act as a vacuum.
- Boiler tanks may contain bacteria and mold, or chemicals to prevent freezing or corrosion. Boilers create back pressure that pushes contaminated water back into the water supply.

What can I do to prevent backflow?

- Install approved, testable backflow preventers on lawn irrigation systems.
- Be aware of and eliminate cross-connections.
- Do not submerge hoses or place them where they could become submerged.
- Use vacuum breakers on hose bibbs or faucets where there is a hose connection (in the basement, laundry room and outside).
- Do not create a connection between an auxiliary water system (well, cistern, body of water) and the drinking water system.

Violations & Corrective Actions

During a sanitary survey of the City of Cuyahoga Falls public water system on October 18 and November 7, 2022 by the Ohio EPA there were several reporting violations.

- The City of Cuyahoga Falls public water system was in violation for failing to provide proper records of inspections for Ross Park Water. The future status of Ross Park's Water Tank will be determined in the first half of 2025 after a tank inspection is completed. The results will be supplied to the Ohio EPA.
- Failing to provide documentation for the City's backflow prevention and cross-connection control program was the cause of another violation. A meeting was held with the Ohio EPA in January of 2023 to provide status of the current state of the program.

One additional non-reporting violations identified during this survey are as follows:

- The supplemental chlorine booster station at the State Road Water Tank was observed to be inoperable. The City plans to remove the booster station in 2026.

Significant Deficiencies Under Ground Water Rule & Corrective Actions

The following significant deficiencies were brought to the City's attention during a sanitary survey of the City of Cuyahoga Falls public water system on October 18 and November 7, 2022 by the Ohio EPA. Included are the corrective actions that have been or will be taken as required by the Ohio EPA.

- The Water Treatment Plant's Softener Building Pipe Gallery showed significant deterioration. The entire softener building, including the pipe gallery is scheduled to be replaced within next two years. The City is expected to have completed plans from design engineers by the end of 2025 and construction to begin in 2026.

Public Participation and Contact Information

The City of Cuyahoga Falls is constantly working to improve our treatment facilities and drinking water. We hope you agree that our safe and plentiful water supply is one of the many good qualities about living in Cuyahoga Falls. We are committed to providing you with information about your water supply. Definitions

- Maximum Contaminant Level Goal (MCLG): The level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.
- Maximum Contaminant level (MCL): The highest level of contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.
- Maximum Residual Disinfectant Level (MRDL): The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.
- Maximum Residual Disinfectant Level Goal (MRDLG): The level of drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.
- Action Level (AL): The concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.
- Parts per Million (ppm) or Milligrams per Liter (mg/L) are units of measure for concentration of a contaminant. A part per million corresponds to one second in a little over 11.5 days.
- Parts per Billion (ppb) or Micrograms per Liter (µg/L) are units of measure for concentration of a contaminant. A part per billion corresponds to one second in 31.7 years.
- The "<" symbol: A symbol which means less than. A result of <5 means that the lowest level that could be detected was 5 and the contaminant in that sample was not detected.

IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER

Reporting Requirement Not Met for Cuyahoga Falls City PWS

We were required to report **adequate notification of service line material** to the State.

Our system failed to demonstrate to the State that it delivered annual notifications and information to affected consumers with lead, galvanized requiring replacement, or lead status unknown service lines as required by July 1, 2025. Although the failure to comply with the reporting requirement does not create a risk to public health, we are required to inform you of this violation and provide additional information including what we did to correct the situation.

It is important for consumers to know if the water they are receiving has been delivered through a lead, galvanized requiring replacement (GRR), or lead status unknown service line so they can make decisions on whether and what actions to take to reduce their exposure to lead in drinking water.

What should I do?

There is nothing you need to do at this time. You do not need to boil your water or take other actions. Remember, boiling water does not remove lead from water.

What is being done?
