

7 AN ORDINANCE AUTHORIZING THE DIRECTOR OF FINANCE
8 TO INCREASE APPROPRIATIONS IN THE STREET
9 CONSTRUCTION, MAINTENANCE AND REPAIR FUND AND THE
10 GENERAL FUND, AND DECLARING AN EMERGENCY.

12 WHEREAS, it is necessary to increase appropriations to the Street Construction,
13 Maintenance and Repair (SCMR) Fund to provide for expenditures therefrom,
14

15 NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Cuyahoga Falls, County
16 of Summit and State of Ohio, that:

17
18 Section 1. The Director of Finance is hereby authorized to increase appropriations in the
19 Street Construction, Maintenance and Repair (SCMR) Fund, line item Other Operations by
20 \$300,000.

21
22 Section 2. Any other ordinances and resolutions or portions of ordinances and resolutions
23 inconsistent herewith are hereby repealed, but any ordinances and resolutions or portions of
24 ordinances and resolutions not inconsistent herewith and which have not previously been
25 repealed are hereby ratified and confirmed.

27 Section 3. It is hereby found and determined that all formal actions of this Council
28 concerning and relating to the adoption of this ordinance were adopted in an open meeting of this
29 Council and that all deliberations of this Council and of any of its committees that resulted in
30 such formal action were in meetings open to the public, in compliance with all legal requirements
31 including Chapter 107 of the Codified Ordinances.
32

33 Section 4. This ordinance is hereby declared to be an emergency measure necessary for the
34 preservation of the public peace, health, safety, convenience and welfare of the City of Cuyahoga
35 Falls and the inhabitants thereof for the reason that the supplies are necessary for the daily
36 functioning of the Street Department, and provided it receives the affirmative vote of two-thirds of
37 the members elected or appointed to Council, it shall take effect and be in force immediately upon
38 its passage and approval by the Mayor; otherwise it shall take effect and be in force at the earliest
39 period allowed by law.
